3. CITIZEN COMMENTS

Peter Banos expressed interest in a "Mobile Airport Hanger" for rent at the New Coalinga Municipal Airport. Mayor Lander stated that Staff would look into his request.

Scott Rathburn, Health Center Manager of United Health Center of Huron, California reported that the Urgent Care in Huron is now open seven days a week.

Mr. Matthew Apple, aka John Sunlight, self-appointed Emperor of Coalinga, requested that more help be made available to those individuals who fall through the cracks, those who are eccentric, or those who have trouble functioning in society.

Bill Lewis asked everyone to please remember to vote at the Special Election on March 5th for Ballot Measure R regarding the sale/lease option to reestablish the Coalinga Hospital. There will be a couple of Town Hall meetings scheduled a few weeks prior to the Election to help answer any questions.

Mary Jones stated her plans to move forward with taking over the Community Garden and enter in to a new Lease with the City of Coalinga.

Terri Yanez pointed out that the light above Councilman Singleton has been out for some time and asked if it could be replaced.

Ms. Yanez stated how nice the Christmas décor was but asked when the decorations would be taken down. Mayor Lander informed her that the responsibility was with another entity.

Ms. Yanez announced the following:

Ms. Yanez went on to announce that Best Western is open! She, along with many others, attended the ribbon cutting earlier this evening and the facility is very nice. She also expressed how supportive they have been with the community and how pleased she is.

Laura Taylor, District 1, brought up the homeless camp set up at the gazebo on the Plaza and asked what was being done about it. She expressed concern because she is a photographer and often receives requests for pictures to be taken at that location. Mayor Lander agreed that it is quite a problem and that the City is trying work through how to solve it. Mayor Lander indicated that the State has recently implemented some new laws that have tied the City's hands.

Mary Jones suggested leasing or selling the gazebo so it would no longer be considered "public" which would allow the City to enforce the homeless issue and deem it a public nuisance.

6. ORDINANCE PRESENTATION, DISCUSSION AND POTENTIAL ACTION ITEMS

 Discussion, Direction and Potential Action Regarding the Appointment of Council Members to Serve on the Committees Established by the Transparency and Accountability Committees Act Marissa Trejo, City Manager

City Manager Marissa Trejo gave a brief overview of the item, recommending that the Council fill the Council seats recently left vacant by Nathan Vosburg's departure from the Council.

Motion by Stolz, Second by Adkisson **Approving** Mayor Lander to act as the Chair of the Sales Tax Revenue and Expense Committee and Councilman Singleton to act as the Co-Chair of the Cannabis Committee. Motion **Approved** by a 4/0 Majority Voice Vote. Ramsey Absent.

2. Discussion, Direction and Potential Action Regarding the Implementation of a City of Coalinga Military/Veteran's Banner Program

Marissa Trejo, City Manager

City Manager Marissa Trejo explained that there was no staff recommendation, as this was a Future Agenda Item brought forward by Councilman Adkisson. Ms. Trejo further explained, should the program become active that it would be at no cost to the City as the cost would be absorbed by the applicant.

Councilman Adkisson explained the details of how the program would work. The estimated cost of a banner is \$65. Mr. Adkisson recommends that the City pay the cost for anyone who has been killed in a war and had their primary residence in the City of Coalinga at the time of their death.

Bill Lewis suggested that the City reach out to the Baker Museum for information regarding those individuals.

Mary Jones suggested that the City could also reach out to David Davenport, who is a local historian, for additional information.

City Attorney Mario Zamora added, should anyone be interested, a relatively local community who has a similar program is the City of Porterville.

Mayor Lander suggested that the City contact the City Manager of Porterville to request information on how their program works.

Police Chief Michael Salvador mentioned that Kerman also has a similar program.

Councilwoman Stolz asked about disadvantaged vets, those who can't afford the cost or have no family. She suggested that we plan to incorporate that into the program.

Ms. Trejo indicated that Staff could include something for disadvantaged vets, if there was a consensus from the Council, however the City would need to set parameters of how we would determine what qualifies as "disadvantaged".

Consensus of the Council is to have Staff draft a City of Coalinga Banner Program and bring it back for Council's consideration.
