Motion by Adkisson, Second by Singleton to Pull Awards, Presentation, Appointments and Proclamations Item 2.1 from the Agenda and Approve the Agenda for the Meeting of August 15, 2019. Motion **Approved** by a 5/0 Majority Voice Vote.

2. AWARDS, PRESENTATIONS, APPOINTMENTS AND PROCLAMATIONS

1. Presentation by Mary Leal, Director of the Coalinga-Huron Library District

2. Swearing in of Public Safety Dispatcher Brady Kaiser

Interim Police Commander Sean Young swore-in new Public Safety Dispatcher Brady Kaiser.

3. CITIZEN COMMENTS

Miss Morgan Vreeland voiced concern over all the stray dogs roaming around town.

Ms. Leona Krueger recounted an instance when she rescued a stray dog from getting hit. Ms. Krueger suggested the City have a fundraiser to address the issue.

Mr. Nathan Vosburg asked the Council to provide an update on the truck ordinance. He commented on all the people who were present for the last Planning Commission Meeting on August 13, 2019. He urges the Council to vote NO on the Adventist Zoning Text Amendment when it is brought forward for consideration.

Mayor Lander stated the truck ordinance is in place and is currently being enforced.

Mayor Pro-Tem Ramsey pulled Item No. 5.2 for discussion.

Mayor Pro-Tem Ramsey asked Community Development Director Sean Brewer, didn't we recently performed an analysis on the lighting?

Mr. Brewer stated the Council did approve a lighting study about a year ago, however it was never conducted. Just as we were about to get started, PG&E began transitioning all the HPS lights to the LED. Staff wanted to wait until the new lights were in place since there was a significant change to the illumination with the switch.

6. ORDINANCE PRESENTATION, DISCUSSION AND POTENTIAL ACTION ITEMS

 Council Consideration and Approval of Resolution No. 3909 Establishing Specific Distance Requirements for Parking Near Fire Hydrants within the City of Coalinga Sean Brewer, (I) Public Works & Utilities Director

Community Development Director Sean Brewer gave a brief overview of the item.

Mayor Lander asked if it would be 7 feet on each side of the hydrant?

Mr. Brewer answered yes, it would be a total of 14 feet. Currently it is 15 feet on each side for a total of 30 feet, which is excessive.

Mayor Lander stated he just wanted to make sure it was going to be enough space, if it was only 7 feet total, it wouldn't be. Has staff started?

Mr. Brewer indicated staff was waiting until this resolution was adopted in order to ensure the right distance requirements before we started painting.

Mayor Lander mentioned how needed the restriping is in the downtown area.

Motion by Adkisson, Second by Stolz to **Approve** Resolution No 3909 Establishing Specific Distance Requirements for Parking Near Fire Hydrants within the City of Coalinga. Motion **Approved** by 5/0 Roll-Call Vote.

City Manager Marissa Trejo asked for clarification, do you want separate reports for Measure J revenues and Have-A-Heart revenues? Or one report that shows both?

Councilman Adkisson stated one report would be fine.

Councilman Adkisson asked for status on a previous request for information on the rent for airport hangers.

Administrative Analyst Mercedes Garcia stated we are still using the quarterly rate. I will get with Jasmin on a rate study.

Councilman Adkisson mentioned moving towards an at large Mayor and four districts so people are voting for the Mayor instead of the Council appointed the Mayor position.

Mrs. Trejo asked, you would like an item brought back to discuss that?

Councilman Adkisson answered, yes.

Councilman Adkisson asked if the Transient Occupancy Tax is generated quarterly?

Mrs. Trejo answered, I believe so.

Councilman Adkisson requested an update on it.
