2. AWARDS, PRESENTATIONS, APPOINTMENTS AND PROCLAMATIONS

1. Presentation from City Staff and Fresno Local Agency Formation Commission (LAFCo) on the Annexation Process

Assistant City Manager Sean Brewer gave a brief presentation before introducing Jessica Gibson and Amanda Castro from LAFCo.

Ms. Gibson provided further information on the annexation process.

Renee Musokian of The CrisCom Company presented their quarterly report.

3. CITIZEN COMMENTS

The following individual(s) spoke under Citizen Comments:

Mrs. Hilda Crawford with the Coalinga-Huron Library District announced that the Library will be holding their 2022 Fall Festival each Wednesday from 5:30pm to 8:00pm in the month of September. The Library is currently seeking vendors and performs interested in participating in the event.

Mr. Nathan Vosburg spoke in opposition to the proposed rate increases. (Item No. 4.2) (Item No. 5.6).

Mrs. Mary Jones commented that some residents are following the water conservation regulations, while other are not. Mrs. Jones inquired if the Coalinga-Huron Recreation and Parks District will be watering at night as directed.

4. PUBLIC HEARINGS

 Continued Public Hearing for the Introduction and Waiving of the First Reading of Ordinance No. 853 – City Initiated Zoning Text Amendment (No. STA 22-01) Amending the Planning and Zoning Code Related to Accessory Dwelling Units (ADU's), Floodplain Regulations and Density Bonus Sean Brewer, Assistant City Manager

Assistant City Manager Sean Brewer gave a brief overview of the item. Changes taken from Council direction at the previous meeting have been highlighted.

Mayor Ramsey asked for confirmation that the requirement that the ADU must have alley access had been removed?

Mr. Brewer confirmed that the requirement had been removed.

Mayor Ramsey asked if the zoning would need to be updated since most areas are zoned for single family.

Mr. Brewer indicated a rezone would not be required, the State has updated the law and ADUs and JADUs are consistent with the General Plan.

Mayor Ramsey asked if Council could allow in only certain residential areas?

Mr. Brewer indicated that it was originally setup in that way with allowing them on properties with alley-access only.

Mayor Ramsey spoke in opposition of allowing garage conversions due to possibility of it lowering the property values. Mayor Ramsey asked if they could be allowed on a case-by-case basis?

Mr. Brewer indicated that we could not, we would need uniformity.

Mayor Ramsey stated that he cannot support this.

Mr. Brewer suggested that we continue the Public Hearing and bring the item back when all Councilmembers are present for the discussion.

City Manager Marissa Trejo suggested that the item be brought back with only allowing for detached garage conversions.

Nathan Vosburg expressed opposition, stating this is a large mistake on the State's part, along with many others. He would like to see the City fight having to implement this, however he understands that our hands are tied.

Motion by Singleton, Seconded by Horn to Continue the Public Hearing to the next Council Meeting scheduled for September 1, 2022. Motion **Approved** by a 3/0 Roll-Call Majority Vote. (Ramirez and Adkisson – Absent)

2. Adopt Resolution No. 4111 Postponing the Increase of the Refuse Rates from July 1, 2022 to September 1, 2022

City Attorney Mario Zamora gave a brief overview of the item, stating that approximately 45,000 notices were mailed out on June 30, 2022, to all residents and to my knowledge there have been no protest votes.

Mayor Ramsey opened the Public Hearing for comments.

Mr. Nathan Vosburg spoke in opposition of the increase at this time. He blames the State of California.

Mr. Zamora asked Mr. Vosburg if he was casting a vote one way or another.

Mr. Vosburg stated he was not.

Mayor Ramsey closed the Public Hearing.

Motion by Ramsey, Second by Horn to Adopt Resolution No. 4111 Postponing the Increase of Refuse Rates from July 1, 2022 to September 1, 2022. Motion **Approved** by 3/0 Roll-Call Majority Vote. (Ramirez and Adkisson – Absent)

Mayor Pro-Tem Singleton, Mayor Ramsey and Councilman Horn spoke in opposition of allowing residents to obtain another source of water.
