I. RECOMMENDATION:

The City Manager recommends the City Council adopt Resolution No. 3997 accepting and approving the results from the November 3, 2020 Consolidated General Election.

II. BACKGROUND:

On November 27, 2020 Brandi L. Orth, County Clerk/Registrar of Voters for the Fresno County Elections Department, certified results of the November 3, 2020 Consolidated General Election. 73.88% of the registered voters cast their vote. Attached is the Statement of Votes Cast.

III. DISCUSSION:

The following Candidates, who shall each serve a four (4) year term, were elected by the voters to serve as Members of the City Council:

District No. 2
James Horn

District No. 4
Jose Manny Ramirez

There were no Qualified Candidates on the ballot for the City Clerk's position.

Dawn Kahikina, who shall each serve a four (4) year term, was elected by the voters to serve as the City Treasurer.

Measure B, a local ballot measure transitioning the office of the City Clerk from an elected position to an appointed position, passed with the minimum required percentage needed (50% +1) as set forth in the attached Statement of Votes Cast.

RESOLUTION NO. 3997

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COALINGA ACCEPTING AND APPROVING THE RESULTS OF THE CONSOLIDATED STATEWIDE GENERAL ELECTION HELD IN THE CITY OF COALINGA ON NOVEMBER 3, 2020

WHEREAS, on Tuesday, November 3, 2020, a Statewide General Election was held in the City of Coalinga in accordance with the law, and the votes thereat were received and canvassed, and the results thereof were ascertained, determined and declared in all respects as required by law. (See **Exhibit A**).

NOW, THEREFOR, BE IT RESOLVED, by the City Council of the City of Coalinga as follows:

1. The total number of votes cast at said election were as follows: Registered Voters 5,765; Total Votes Cast 4,259; Turnout Percentage 73.88%.
2. Candidates running for Councilmember positions in District No. 2 and District No. 4 received the following votes:

District No. 2	District No. 4
James Horn 393 (57.79%)	Ruth Thurman 105 (19.13%)
Andrea Rosas 287 (42.21%)	Kevin Donaldson 131 (23.86%)
	Jose Manny Ramirez 313 (57.01%)

3. The top candidates elected to each District by the voters as Members of the City Council were:

District No. 2: James Horn
District No. 4: Jose Manny Ramirez

These candidates shall each serve full four (4) year terms.

4. No Qualified Candidates ran for the office of City Clerk.
5. Candidates running for the office of City Treasurer received the following votes:

City Treasurer
Dawn Kahikina 2,802 (100.00%)

This candidate shall serve a full four (4) year term.

6. Measure B: Transitioning the Office of the City Clerk from an Elected Position to an Appointed Position – 50% +1 needed to pass:

Shall the office of the City Clerk be appointive?

YES: 1,981 (51.53%)
NO: 1,863 (48.47%)

7. The City Clerk shall immediately make and deliver to each person so elected, a Certificate of Election signed by the City Clerk and authenticated. The City Clerk shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribed to it and file it in the Office of the City Clerk. Each and all persons so elected shall then be introduced into the respective office which they have been elected.
