#### I. RECOMMENDATION:

Financial Services Director recommends the City Council adopt Resolution No. 4095 to continue an existing ad valorem pension property tax at a rate of \$0.0720 per \$100 of assessed property value for the purpose of raising revenue to fund the City's obligation to the pension and retirement fund for the City's public safety employees. The property tax will be continued at the same rate that was imposed in the 1982-83 fiscal year as permitted by Revenue and Taxation Code Section 96.31(a)(4).

#### II. BACKGROUND:

The ad valorem pension property tax is provided through the State of California Revenue and Taxation Code Section 96.31, paragraph (a)(4) which reads as follows:

"For the 1985-86 fiscal year and for each fiscal year thereafter, a jurisdiction shall not impose a property tax rate pursuant to subdivision (a) of section 96, unless it is imposed for one or more of the following purposes (4) to make payments in support of pension programs approved by the voters before July 1, 1978, provided that the local agency imposed the property tax rate in the 1982-83 fiscal year."

#### V. FISCAL IMPACT:

For Fiscal Year 2021-2022, revenue received was \$450,000 and retirement program costs were \$545,068. This property tax funded an estimated 83% of retirement costs for public safety employees appropriated from the general fund for fiscal year 2021-2022. For Fiscal Year 2022-2023, projected revenue is \$515,000 and estimated retirement program costs are \$601,928. The property tax is expected to fund an estimated 86% of retirement costs for public safety employees appropriated from the general fund for fiscal year 2022-2023.

#### **RESOLUTION NO. 4095**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COALINGA DETERMINING THE NECESSITY OF RAISING REVENUE BY TAXATION FOR THE PURPOSE OF MEETING THE CITY'S OBLIGATION TO THE PENSION AND RETIREMENT FUND FOR PUBLIC SAFETY EMPLOYEES OF THE CITY

**WHEREAS**, the State Supreme Court has ruled that the indebtedness created by the electorate to pay for a City pension fund is within the specific tax authority provided by the voters in Article XIII-A on pension plans instituted prior to July 1, 1978; and

**WHEREAS**, the ad valorem property tax is provided through the State of California Revenue and Taxation Code Section 96.31, paragraph (a) (4) and

**WHEREAS**, it is necessary to raise money in order to meet the City's obligation to the retirement fund for the public safety employees of the City; and

**WHEREAS**, it is determined that an amount of \$0.0720 on each \$100 of assessed property value is necessary to raise sufficient revenue to pay the cost thereof;

#### NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Coalinga as follows:

1. That an ad valorem property tax in the amount of \$0.0720 on each \$100 of assessed property value is hereby fixed for the Fiscal Year 2022-2023 for the purpose of meeting the City's obligation to the pension and retirement fund for public safety employees of the City and to be collected by the Fresno County Auditor's Office.

#### I. RECOMMENDATION:

The City Manager recommends that the City Council appoint Lonnie A. Hedgecock to the office of City Councilmember for District #5.

#### II. BACKGROUND:

Section 10229 of the Elections Code states that if a candidate is unopposed at the close of nominations, a city council can:

- 1. Appoint to the office the person who has been nominated;
- 2. Appoint to the office any eligible voter if no one has been nominated; or
- 3. Hold an election if either no one or only one person has been nominated.

#### III. DISCUSSION:

As of the close of the nomination period on August 17, 2022, Lonnie A. Hedgecock was the only nomination to the District #5 council seat. Under the above code section, the City Council can appoint Mr. Hedgecock to that seat.

The appointment of Mr. Hedgecock to District #5 would occur in lieu of the election, therefore he would qualify and take office and serve exactly as if elected at a municipal election for the office.

The appointment shall not affect the conduct of the municipal election in any other legislative districts of the City.

#### IV. ALTERNATIVES:

Do not appoint Lonnie A. Hedgecock to District #5 and instead have the election for District #5 continue.

#### V. FISCAL IMPACT:

The Fresno County Elections Office estimates a \$2,500 cost savings for the City of Coalinga by making the appointment for District #5 in lieu of the election. This cost savings would be to the City's General Fund.

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COALINGA APPOINTING UNOPPOSED COUNCILMEMBER FOR DISTRICT #5

**WHEREAS**, the City of Coalinga has scheduled a General Municipal Election on November 8, 2022, to elect one (1) City Councilmembers; and

**WHEREAS**, at the close of the nomination period on August 17, 2022 there was only one candidate nominated for the office to be elected at the General Election to fill the vacancy for District #5 of the City Council of the City of Coalinga; and

**WHEREAS**, on August 19, 2022, the City Clerk submitted a written certification providing there are not more candidates nominated than offices to be elected for the office of City of Coalinga Councilmember, District #5, at the General Municipal Election; and

**WHEREAS**, Section 10229 of the Election Code allows one of the following courses of action to be taken by the City Council:

- 1. Appoint to the office the person who has been nominated;
- 2. Appoint to the office any eligible voter if no one has been nominated;
- 3. Hold the election if either no one or only one person has been nominated; and

**WHEREAS**, a notice was published on August 19, 2022 in a newspaper of general circulation pursuant to state law with the City Clerk's certification; and

**NOW THEREFORE BE IT RESOLVED**, that pursuant to Section 10229 of the Election Code the following action is being taken:

Lonnie A. Hedgecock, being the only candidate for the office for which he is nominated, being appointed to the office and considered to be the same as being elected to the City Council with a term of four years.

**NOW THEREFORE BE IT FURTHER RESOLVED**, that person appointed, shall qualify and take office and serve exactly as if elected at a municipal election for the office.
