I. RECOMMENDATION:

Receive a presentation from the Sports Car Club of America (SCCA) regarding potential autocross and rallycross events at the Coalinga Municipal Airport and provide direction to staff as appropriate on next steps.

II. BACKGROUND:

At the request of Councilmember Lowder, this item has been agendaized for general discussion to allow the Sports Car Club of America (SCCA) to present an overview of its organization and its interest in potentially hosting motorsports events at the Coalinga Municipal Airport.

SCCA is a national motorsports organization founded in 1944 with over 65,000 members nationwide. Through its regional chapters, SCCA conducts sanctioned autocross (“SOLO”) and rallycross events across the country at a variety of sites, including parking areas, airfields, and other large open facilities.

The Fresno SCCA Chapter, which has operated in the Central Valley for more than 30 years, will provide the presentation.

III. DISCUSSION:

During the presentation, SCCA representatives will provide a general overview of:

- The nature and format of autocross and rallycross events;
- How events are typically conducted at airport and similar facilities;
- High-level safety, insurance, and operational practices; and
- Potential community and economic benefits associated with hosting regional events.

This item is intended to be informational with possible direction from the Council for staff to further explore the opportunity at the Airport. No approvals, commitments, or agreements are being requested at this time. Any future consideration of airport use would require additional analysis, coordination with airport operations and the FAA, and formal City Council approval.

I. RECOMMENDATION:

Financial Services Director recommends that City Council authorize the City Manager to approve and sign the agreement with Price Paige & Company to provide professional services for a comprehensive revamp of the City's Chart of Accounts (COA).

II. BACKGROUND:

The revamp of the Chart of Accounts is part of the City's one-time projects approved during the FY 2025–26 budget hearings. This effort provides significant value to the City, as the existing Chart of Accounts was established many years ago with minimal standards and limited structural guidance.

Over the years, additional accounts were created without a comprehensive understanding of accounting best practices or long-term financial reporting needs. As a result, the current structure has led to:

- Inconsistent account numbering and hierarchy
- Improper or unclear grouping of categories
- Accounts that do not align with GASB reporting standards
- Difficulty in preparing accurate and timely financial statements
- Increased staff time required for reconciliation and financial analysis

As a result, the current COA structure no longer supports the City's operational needs or the level of reporting required for audits, financial transparency, and sound fiscal management. Price Paige & Company, has been a longstanding fiscal accounting advisor for the City and is well acquainted with the existing COA and the challenges staff encounter during audit preparation and year-end reporting.

III. DISCUSSION:

Price Paige & Company has reviewed the City's Chart of Accounts and determined that a full restructuring is necessary to:

- Establish a logical, consistent, and standardized COA framework
- Ensure alignment with governmental accounting best practices and GASB standards
- Improve the accuracy and efficiency of financial reporting and budget development
- Reduce staff time spent on manual adjustments, reclassifications, and reconciliations
- Lay a foundation compatible with future financial system upgrades and technology improvements

Price Paige & Company possesses extensive experience in governmental accounting and has successfully completed similar COA modernization projects for other public agencies. Their proposed scope of work includes:

- Review of all existing accounts
- Development of a new structured hierarchical COA
- Mapping of legacy accounts to the new system
- Implementation support and staff training

This modernization will significantly strengthen the City's financial management framework and enhance transparency for the public, City Council, and auditors.

I. RECOMMENDATION:

City Council is hereby recommended to adopt Resolution No. 4303 and approve an agreement to receive up to 700 AF of USBR project water from Westlands Water District on behalf of Gladstone California Water LP on Gladstone properties within Coalinga's USBR place of use.

II. BACKGROUND:

Over the past years, the City has done many water transfers on behalf of farmers operating within the City's service area. Typically, water transferred into Coalinga's service area is from districts other than Westlands Water District. However, this requested transfer is from within Westlands. As a condition for Westlands board of directors to approve the transfer, the board requires a like amount of water to be transferred back into Westlands by the City of Coalinga. Westlands proposed transfer agreement with the City allows 10 years for the water to be redelivered to Westlands. This requested transfer is different because other transfer agreements in the past have not required redelivery to the water district originating the water.

III. DISCUSSION:

The City's service fee to Gladstone for this transfer is increased from the typical \$25 per acre foot to \$50 per acre foot due to the additional administrative burden of managing and tracking water to be redelivered to Westlands on Gladstone's behalf into the foreseeable future. The source of the redelivery water will be either a) Future water purchased by Gladstone from the City, or b) Future water transferred in by Gladstone that is not Westlands water. Whichever, the first water in shall be deemed redelivery to Westlands. Language is included for Gladstone to indemnify the City for the City's risk of redelivery to Westlands.

Minor changes that are non-substantive may be requested by Gladstone in the attached agreement. Any changes shall be reviewed and approved by the City Attorney.

IV. ALTERNATIVES:

The alternative is not to receive water from Westlands Water District on behalf of Gladstone.

V. FISCAL IMPACT:

If all 700 AF are conveyed in January and February, the net benefit to Coalinga's water rate payers will be \$35,000.

WHEREAS, City desires to convey the water, under specified terms and conditions, for the mutual benefit of all parties, and in conformity with applicable State and Federal regulations; and

WHEREAS, Gladstone California Water LP has agreed to indemnify the City for the risk the City will take in redelivery of a similar amount of water back to Westlands.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Coalinga does hereby approve the transfer and conveyance of water in accordance with the terms and conditions of the attached agreements to this Resolution, as follows.

1. Agreement with Westlands Water District for the transfer of water during January and February 2026.
2. Agreement with Gladstone California Water LP for the transfer and conveyance of water during January and February 2026.

**WATER TRANSFER AGREEMENT BETWEEN
CITY OF COALINGA AND
WESTLANDS WATER DISTRICT**

This Agreement is made this ____ day of January 2026, by and between Westlands Water District (WWD) and the City of Coalinga (Coalinga).

RECITALS

- A. WWD is a public agency of the State of California and Coalinga is an incorporated city of the State of California, duly formed and operating under the laws of the state, and are empowered to enter into contracts to manage the water supply available to them for the benefit of their constituents.
- B. WWD is a contractor entitled to receive water which it can beneficially use from the Central Valley Project (CVP) administered by the U.S. Department of Interior, Bureau of Reclamation (Bureau) pursuant to WWD's Contract No. 14-06-200-495A-IR1-P. Coalinga is a contractor with the Bureau and is entitled to receive CVP water pursuant to Coalinga's Contract No. 14-06-200-4173A-IR1-P.
- C. Coalinga anticipates a water supply insufficient to meet its 2025/26 water demands and desires to obtain additional water supplies from other entities which take delivery of water from the San Luis Unit.
- D. WWD has, pursuant to Water Code Section 383, determined there is water that is temporarily surplus to the needs of WWD and one of its landowners.
- E. WWD is willing to transfer **up to 700 acre-feet (AF)** of 2025 CVP Contract Water to Coalinga, during the remainder of the Contract Year (CY), for the exclusive use: (1) by a landowner that is common to both WWD and Coalinga (Common Landowner), and (2) on lands that are owned by said Common Landowner and eligible to receive CVP water within Coalinga's service area.
- F. The transfer under this agreement is consistent with authority granted to WWD under Water Code Sections 382 and 35425.
- G. Coalinga and WWD have determined that the transfer under this Agreement will have no significant environmental impact, will remove no additional water from the Delta and shall

not increase the cost, nor reduce the supply of water to other CVP contractors.

AGREEMENT

1. This Agreement shall remain in effect until such time all the applicable water has been returned to WWD, or ten (10) years, whichever is earlier.
2. Water returned to WWD under the terms of this Agreement is for the benefit of the specific WWD Water User(s) and is not for the direct or indirect benefit of other water districts that are not parties to this Agreement.

DELIVERY AND COST OF CVP WATER TO COALINGA

3. For the sole and exclusive use by the Common Landowner during the 2025/26 CY and on lands that are owned by the Common Landowner and eligible to receive CVP water within Coalinga's service area, WWD will deliver to Coalinga, **up to 700 AF** of CVP water, prior to February 28, 2026, and pursuant to the terms and conditions of the Bureau's approval, including the schedule developed by WWD and Coalinga (see forecast delivery schedule Exhibit A).
4. The amount of water transferred to Coalinga will be within the sole discretion of WWD and will be subject to the Common Landowner causing an equal amount of water to be made available from their water user account for transfer to Coalinga.
5. WWD shall deliver the water to Coalinga at points on the Coalinga Canal, as provided by the separate conveyance agreement between WWD and Coalinga, dated July 6, 2017.
6. Deliveries of water from WWD to Coalinga shall be measured by WWD.
7. WWD agrees to pay the United States Bureau of Reclamation contract rate, Restoration Fund, and additional rates for CVP services required to effectuate the transfer.
8. Coalinga is responsible for paying the San Luis & Delta-Mendota Water Authority O&M charge.
9. The payment of charges required by Section 8 immediately above are in addition to the rates and charges the Common Landowners will be obligated to pay pursuant the Westlands Water District's Rules and Regulations and Terms and Conditions of Water

Service.

10. WWD may terminate this Agreement upon 14 days of advanced written notice to Coalinga.

DELIVERY OF RETURN WATER TO WWD

11. Pursuant to the terms and conditions of Bureau's approval and other approvals as may be required, Coalinga will make available to WWD and WWD will make available to the applicable WWD Water User(s) amounts of return water equal to the actual amounts of WWD's CVP water delivered to Coalinga. All deliveries shall be made pursuant to a schedule approved by Bureau, in coordination with Coalinga and WWD.
12. The point of delivery of return water to WWD shall be from WWD turnouts in Reaches 4-7 of the joint-use San Luis Canal portion of the California Aqueduct or at points on the Coalinga Canal.
13. Deliveries of return water from Coalinga to WWD shall be measured by the Department of Water Resources (DWR).

APPROVALS

14. The performance by both parties to this Agreement is contingent upon and subject to approval of the Bureau and the terms and conditions thereof.

MISCELLANEOUS

15. WWD and Coalinga shall cooperate in securing Bureau approvals.
16. Coalinga agrees to abide by all provisions of Reclamation Law.
17. Any notice, request, tender, demand, delivery, approval or other communication providing for, required, or arising under this Agreement shall be in writing and shall be deemed delivered three business days after deposit in the United States mail, addressed to the party as follows:

**WATER CONVEYANCE AGREEMENT
CITY OF COALINGA AND GLADSTONE CALIFORNIA WATER LP, A DELAWARE
LIMITED PARTNERSHIP**

Agreement for Westlands Water District Transfer During January and February 2026

This Agreement is entered into by and between the City of Coalinga (“City”) and Gladstone California Water LP, a Delaware Limited Partnership (“GCWLP”), (“the Parties”) with respect to the following Recitals, which are a substantive part of this Agreement.

RECITALS

WHEREAS, GCWLP desires to transfer water through the City of Coalinga’s conveyance agreement with Westlands Water District (Westlands) to GCWLP’s parcels within the City’s place of use; and

WHEREAS, GCWLP transfer water shall originate from Westlands Water District, a contractor with the United States Department of the Interior, Bureau of Reclamation (USBR) that is entitled to receive Central Valley Project (CVP) water (Project Water); and

WHEREAS, the City is a contractor with USBR and is entitled to receive CVP water pursuant to USBR Contract No. 14-06-200-4173A-IR1-P; and

WHEREAS, water to be transferred herein is from Westlands Water District place of use; and

WHEREAS, Westlands requires redelivery to Westlands place of use from the City of Coalinga an equal amount of water transferred and conveyed herein to Coalinga’s place of use; and

WHEREAS, GCWLP shall indemnify the City of Coalinga for the City’s risk associated with future redelivery of water to Westlands; and

WHEREAS, GCWLP shall be responsible for paying to the City any San Luis & Delta-Mendota Water Authority (SLDMWA) charges actually paid to SLDMWA. GCWLP shall also be responsible for paying COC for other costs and charges as may be imposed upon the Transfer Water by COC, including the Coalinga wheeling fee of \$50.00/AF and WWD’s canal maintenance fees (which will be paid by Coalinga to WWD).

NOW, THEREFORE, City and GCWLP agree to the following:

1. Term of Agreement. The Agreement shall terminate following completion of redelivery water to Westlands Water District or as otherwise agreed by the Parties.
2. Delivery and Redelivery Schedule:
 - A. Delivery to City of Coalinga: GCWLP anticipates transferring in January and February 2026, up to 700 AF of water to which it is entitled held within Westlands Water District.
 - B. Redelivery to Westlands: GCWLP, either by transfer of water other than Westlands supply or by future purchase (when available) from the City of Coalinga shall provide an equal volume of water to the City of Coalinga to satisfy Westlands

redelivery requirement. Pricing terms for such redelivery water shall be mutually agreed between the City and GCWLP. The Parties agree that the first volumes either purchased by or transferred to the City shall be redelivery water to Westlands, to the extent the Westlands area served by the Coalinga Canal can take the water.

3. Indemnification. GCWLP agrees to indemnify the City of Coalinga for the financial risk the City is taking pursuant to Westlands requirement to have a like amount of water delivered back to Westlands by Coalinga. GCWLP's responsibility shall be limited to a cost up to \$500 per acre foot delivered into the Coalinga Canal (before Coalinga Conveyance Fees and before San Luis and Delta-Mendota Water Authority Fees).
4. Fee for Water Conveyed. The fee for water conveyed shall be the sum of:
 - A. San Luis and Delta-Mendota Water Authority Fee,
 - B. Westlands Canal Maintenance Fee,
 - C. Twenty-five dollars (\$50) per AF, and
 - D. Any other fees incurred by City for conveyance only.

GCWLP shall provide, or cause to provide, evidence of delivery of all Project Water conveyed by City on a monthly basis prior to the 10th day following each month of conveyance.

5. Notices, Billing, and Payment. City shall issue billing statements to GCWLP following each month of water deliveries. Payment shall be rendered by GCWLP to City within fifteen (15) days of the date of the statement. Notices, including billing statements may be communicated via email, provided the receiving party acknowledges receipt.

6. Delivery Point. The Delivery Point for water sold hereunder shall be GCWLP's turn-out located near the end of the Coalinga Canal.

7. Redelivery Point. Delivery of return water to Westlands shall be to the Westlands turnouts in Reaches 4-7 of the joint-use San Luis Canal portion of the California Aquaduct, or at points on the Coalinga Canal, or at points otherwise acceptable to Westlands.
8. Regulatory Compliance. The obligations of City and GCWLP to perform under this Agreement are conditioned upon ongoing compliance, approvals, and consents, including without limitation consent from the USBR, Westlands Water District, the State Water Resources Control Board, and any other authority with jurisdiction impacting this Agreement.
9. Conflicts of Interest. Neither City, nor its City Manager, nor any City Council member, department head, manager, employee, consultant, or agent of City, shall give to or receive from any director, employee or agent of GCWLP or any affiliate thereof any gift or entertainment of significant value, or any commission, fee, or rebate in connection with this Agreement.
10. GCWLP. This Agreement is being entered into with GCWLP.
11. Operating Communication. The City shall designate a representative for ongoing operating coordination with GCWLP, and similarly GCWLP shall designate a representative authorized to represent GCWLP for operating coordination.
12. Counterpart Signatures. The parties hereto agree that this Agreement may be signed in counterparts such that each signature alone or combined with others agrees to this single binding Agreement.

I. RECOMMENDATION:

Authorize staff to advertise and solicit a Request for Qualifications (RFQ) from qualified videographers and photographers for professional media services related to the City's Wings Over the Westside Airshow scheduled for October 3, 2026.

II. BACKGROUND:

Wings Over the Westside is the City of Coalinga's signature aviation and community event held at the Coalinga Municipal Airport. The event includes aerial performances, static aircraft displays, a classic car show, vendor and sponsor activations, and family-friendly activities. Professional videography and photography are essential to documenting the event, promoting tourism and economic development, engaging the community, supporting sponsorship efforts, and producing marketing materials for future airshows.

Staff has prepared a Request for Qualifications (RFQ) to solicit statements of qualifications from experienced videographers and photographers capable of providing event coverage and post-production services. The RFQ is structured to identify the most qualified firm based on experience, demonstrated work quality, and overall approach. The draft RFQ is included for Council review.

III. DISCUSSION:

The City intends to use the RFQ process to identify and rank qualified firms and then negotiate with one top-ranked firm to provide videography and photography services for the Wings Over the Westside Airshow. Subject: Introduce and Waive the First Reading of Ordinance No. 877 - Authorizing the City Manager to Execute City Instruments Pursuant to California Government Code Section 40602

I. RECOMMENDATION:

Introduce and adopt an ordinance authorizing the City Manager to sign warrants, contracts, conveyances, and instruments requiring the City seal, in lieu of the Mayor, pursuant to California Government Code Section 40602.

II. BACKGROUND:

California Government Code Section 40602 requires that the Mayor sign all warrants, contracts, conveyances, and instruments requiring the City seal unless the City Council adopts an ordinance designating another officer to execute those instruments. The statute expressly allows the legislative body to delegate this authority by ordinance.

Historically, the City has relied on the Mayor's signature for execution of these documents. While this approach is compliant with statute, it can create administrative delays when time-sensitive documents require execution, particularly when coordinating with external agencies, grant administrators, and funding partners.

An ordinance authorizing the City Manager to execute these documents would provide clarity, continuity, and operational efficiency while preserving the City Council's authority to approve contracts, agreements, and other actions as required by law.

III. DISCUSSION:

The attached ordinance authorizes the City Manager to sign the instruments described in Government Code Section 40602(a), (b), and (c), including warrants, written contracts and conveyances, and instruments requiring the City seal. Importantly, the ordinance does not delegate approval authority. All existing City Council approval requirements remain unchanged.

This item is being brought forward in response to recent guidance received from Self-Help Enterprises and other housing and grant-administering partners indicating that the California Department of Housing and Community Development (HCD) is increasingly enforcing compliance with Government Code Section 40602. Cities that do not have a compliant signatory ordinance in place may experience delays or obstacles in processing funding amendments, conditional award standard agreements, budget revisions, and future grant awards.

From an operational standpoint, adopting this ordinance will:

- Improve efficiency in executing time-sensitive warrants, contracts, and legal instruments;
- Reduce delays caused by scheduling constraints or procedural bottlenecks;
- Ensure continued compliance with state law and evolving funding-agency requirements; and
- Support the City's ability to efficiently execute enforcement actions, contracts, grant documents, and other instruments necessary for day-to-day operations.

This approach is consistent with best practices across California municipalities and is increasingly being requested by state and regional partners as a condition of funding administration.

IV. ALTERNATIVES:

- **Do not adopt the ordinance** - This alternative would maintain the current practice requiring the Mayor's signature on all instruments, but may result in administrative delays and potential issues with state and funding-agency compliance.
-
- **Adopt a more limited ordinance** - The Council could choose to authorize a different officer or impose narrower execution authority, though this may not fully address efficiency or external agency concerns.

V. FISCAL IMPACT:

There is no fiscal impact associated with adoption of this ordinance. The action is administrative in nature and intended to improve efficiency and compliance.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COALINGA AUTHORIZING THE CITY MANAGER TO SIGN CERTAIN CITY INSTRUMENTS IN LIEU OF THE MAYOR PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 40602

The City Council of the City of Coalinga does ordain as follows:

WHEREAS, California Government Code section 40602 provides that the mayor shall sign: (a) all warrants drawn on the city treasurer; (b) all written contracts and conveyances made or entered into by the city; and (c) all instruments requiring the City seal; and further provides that the legislative body may provide by ordinance that the instruments described in subdivisions (a), (b), and (c) be signed by an officer other than the mayor; and

WHEREAS, the City Council finds that it is in the best interest of the City to ensure efficient and timely execution of City instruments and to clarify signatory authority consistent with the Government Code section 40602; and

WHEREAS, the City Council desires to authorize the City Manager to sign the instruments described in California Government Code section 40602(a), (b), and (c) in lieu of the Mayor, as permitted by law, while preserving all requirements for City Council approval of contracts, conveyances, and other actions where approval is required by law or by the Coalinga Municipal Code;

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. Authority and Purpose

This ordinance is adopted pursuant to California Government Code Section 40602 to designate an officer other than the Mayor to sign the instruments described in subdivisions (a), (b), and (c) of that section.

Section 2. Designation of Officer; City Manager Authorized Signatory

The City Council hereby provides by ordinance that the following instruments described in Government Code Section 40602 may be signed by the City Manager, in lieu of the Mayor:

- (a) all warrants drawn on the city treasurer;
- (b) all written contracts and conveyances made or entered into by the city; and
- (c) all instruments requiring the City seal.

Nothing in this ordinance shall be construed to:

1. Authorize the City Manager (or any officer) to approve or enter into any contract, conveyance, warrant, or instrument on behalf of the City without the required approval under applicable law, the Coalinga Municipal Code, or action of the City Council; or
2. Supersede, waive, or modify any requirement that the City Council approve the underlying act before execution.

The City Manager's authority under this Ordinance is limited to execution/signature of instruments as authorized by California Government Code section 40602 and as otherwise lawfully approved.

I. RECOMMENDATION:

Adopt Resolution No. SA-350 Approving the Recognized Obligation Payment Schedule 26-27 for July 2026 through June 2027 and the Fiscal Year 2026-27 Administrative Budget

II. BACKGROUND:

A Recognized Obligation Payment Schedule (“ROPS”) covering the period of July 1, 2026 through June 30, 2027 is due by February 1, 2026 pursuant to Health and Safety Code (“HSC”) Section 34177(o). The ROPS requests necessary payments for each enforceable obligation of the former Coalinga Redevelopment Agency for Fiscal Year (“FY”) 2026-27.

ROPS 26-27 has been prepared for the Successor Agency Board’s consideration and is attached to this staff report. The Fresno Countywide Oversight Board (“Oversight Board”) would also review the ROPS 26-27 at its meeting on January 22, 2026. Once approved, staff would transmit it electronically to the Department of Finance (“DOF”), State Controller, and Fresno County Auditor-Controller (“CAC”) for their review. The adopted ROPS must be transmitted by February 1, 2026, or the Successor Agency would be subject to a penalty of \$10,000 per day. With DOF approval, the Auditor-Controller would be authorized to disperse property tax revenue to pay ROPS obligations on June 1, 2026 and January 2, 2027.

III. DISCUSSION:

Recognized Obligation Payment Schedule

As per their practice, the DOF provides successor agencies a partially completed ROPS form to standardize the form and make it consistent with the automated tracking system. DOF continues to make minor annual changes to the ROPS forms and process for submitting the ROPS.

Redevelopment Property Tax Trust Funds (“RPTTF”) requested for 26-27 ROPS period payments are net of cash carried over from the ROPS 23-24 period; this cash is referred to as the “prior period adjustment”. The Prior Period Adjustment for ROPS 23-24 was reported by the Coalinga Successor Agency staff to the County Auditor-Controller in September of this year and reported a total of \$12,157 of unspent RPTTF funds carried over from the ROPS 23-24 period.

For ROPS 26-27, the Successor Agency is requesting a total of \$699,571 in Redevelopment Property Tax

Trust Fund money to fund ROPS obligations, \$638,571 for the first half of the fiscal year and \$61,000 for the second half of the fiscal year. The obligations listed on the ROPS include:

- Item #9: \$122,000 for Successor Agency Administrative Budget
- Item #46: \$5,000 for 2018 TARB Continuing Disclosure report
- Item #49: \$5,000 for 2000 Tax Allocation Bonds (TAB) Fiscal Agent Fees
- Item #50: \$3,000 for 2000 TAB Continuing Disclosure report
- Item #51: \$564,571 for 2000 TAB Accreted Interest

It is important to note in advance, that the 2018 TARB were paid off on September 15, 2025 or during the ROPS 25-26 period. Despite this, the Successor Agency will need to remain in existence in order to pay down items #49, #50, #51. These enforceable obligations cover unfunded existing obligations related to the 2000 TAB Accreted Interest portion. The 2000 Bonds were mostly refunded with the 2018 TARB. All line items relating to the 2000 TAB were then retired off of the ROPS in 2018, However, the Accreted Interest portion of the 2000 Bonds, and related fees and disclosure costs, remained outstanding. The Agency has thus far been able to cover the fiscal agent fees (#49) and continuing disclosure costs (#50) for the 2000 TAB with existing RPTTF distributions. In 2026, however, the first 2000 TAB Accreted Interest payment (#51) of \$564,571 will come due. Staff prepared the ROPS 24-25 to include these new items to accurately reflect the situation and prepare for the Accreted Interest payment. DOF approved the return of the 2000 TAB obligations on April 12, 2024. The ROPS 26-27 presented currently continues the inclusion of the 2000 TAB obligations.

With its approval, the Successor Agency ROPS 26-27 would continue the process of dissolving the financial affairs of the former redevelopment agency, which should, based on current obligations, be completed after September 15th, 2030, or the end of the accreted interest portion of the 2000 TAB (Item #51).

Once approved by the Successor Agency, the ROPS 26-27 and the accompanying administrative budget would be considered by the Fresno Countywide Oversight Board.

IV. ALTERNATIVES:

V. FISCAL IMPACT:

For ROPS 26-27, the Successor Agency is requesting a total of \$699,571 in Redevelopment Property Tax Trust Fund money to fund ROPS obligations, \$638,571 for the first half of the fiscal year and \$61,000 for the second half of the fiscal year.

WHEREAS, the ROPS 26-27 includes a proposed administrative budget of \$122,000 for the fiscal year, attached hereto as Exhibit “B”; and

WHEREAS, the Successor Agency desires to approve the ROPS 26-27 and Fiscal Year 2026-27 Administrative Budget and transmit it to various parties as required by the Dissolution Act.

NOW, THEREFORE, the Successor Agency to the Redevelopment Agency of the City of Coalinga resolves as follows:

Subject: Adopt Resolution No. 4304 Modifying The Special Terms of Sewer Rates to Allow Some Exemptions for Sewer Charges Applied to Metered Potable Water That is Not Discharged into the City's Sewer System.

I. RECOMMENDATION:

City Council is recommended adopt Resolution No. 4304 to modifying the special terms of the sewer rate Resolution No.3989, approved October 15, 2020, to allow some exemptions for sewer charge applied to metered potable water that is not discharged into the city's sewer system.

II. BACKGROUND:

Wastewater collection and treatment (sewer) rates for non-residential customers are based on metered potable water into each customer's facility. The current sewer rate for non-residential customers is \$5.49 per thousand gallons potable water metered. The current rates resolution provides for an exemption for non-residential customers with landscape requiring the customer to install a separate landscape water meter for which sewer rates will not be applied. (Installation of a second meter for landscape is a standard practice in new construction.)

However, from recent meetings at Spice World (formerly Sequoia Packing), the large garlic processing facility in the City's Juniper Ridge Industrial Park, staff has become aware that another exemption should also be included. Potable water that is used in their cooling towers is metered into the facility but is not discharged as sewer water because it is evaporated through the cooling process.

III. DISCUSSION:

Pursuant to Proposition 218, as it applies to sewer and water charges, the intent is that customers pay rates in proportion to the cost burden to the city to provide the services. This can never be perfectly applied because to do so every customer would have a different rate mechanism. However, reasonable steps can be taken, such as determining rate classes containing similar types of customers, and by using volume-based rates for non-residential businesses because in most cases water metered in is proportional to water discharged out into the sewer system.

Often for industrial discharge, the discharge itself is directly metered. For larger wastewater systems, metered discharge can be a requirement. Because Coalinga is a smaller city with few large commercial customers, metering of discharge would be cumbersome because of the operating requirements and maintenance required for a wastewater metering and sampling stations. A practical alternative, in this case for Spice World, is to submeter water flow used for cooling in combination with engineering calculations of the percentage of water used for cooling. As this is to the benefit of the customer, the proposed resolution is written such that the

burden and cost will be on the customer to support the determination of water not discharged. Further, acceptance will be at the city's discretion.

IV. ALTERNATIVES:

Do not change special conditions of sewer rates.

V. FISCAL IMPACT:

A few non-residential customers may pay a lower amount of sewer fees; however, the overall revenue impact will be small.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COALINGA
MODIFYING SEWER CHARGE EXEMPTION TERMS FOR METERED POTABLE
WATER THAT IS NOT DISCHARGED INTO THE SEWER COLLECTION SYSTEM**

WHEREAS, Coalinga Municipal Code provides for modifications to sewer rates by resolution of the City Council; and

WHEREAS, sewer (and water) rates were set over a five-year period by Resolution No. 3989, approved by city council on October 15th, 2020; and

WHEREAS, the last increase pursuant to Resolution No. 3989 was effective November 1, 2024; and

WHEREAS, this resolution does not increase rates and is therefore exempt from the procedural requirements of Proposition 218; and

WHEREAS, the existing sewer rate schedule is proposed to include expanded language regarding metered potable water exempt from potable water-based sewer charges when metered water is used for irrigation, cooling towers, or included in products.

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of Coalinga does hereby as follows:

1. The schedule of existing sewer rates, effective November 1, 2024, is unchanged. For convenience, they are attached in Exhibit “A” attached hereto.
2. Clarification language has been added regarding potable water usage by non-residential customers, such that under certain approved circumstances, customers may have exemptions from being billed sewer charges for all metered potable water.

I. RECOMMENDATION:

Council Authorization for the City Manager to execute Task Order for Design Engineering Services for the Coalinga Multi-Trail Segment 7, 8, 9c of the Coalinga Multi-Trail System Funded by the Active Transportation Program.

In November 2025 the City of Coalinga received a grant award notification through the Active Transportation Program (ATP) grant program in the amount of \$83,862.00 to design Segment 7, 8, 9c of the Multi-Use Trail System. Proposed Trail Segment 7 is located on an existing soil path running north to south along the berm of Warthan Creek, approximately 0.76 mi, from W Polk Ave to the proposed roundabout SW. Proposed Trail Segment 8 is located on an existing soil path running north to south for approximately 0.09 along the berm of Warthan Creek and east to west for approximately 0.43 miles from proposed roundabout SW to Pacific and Forest intersection. Proposed Trail Segment 9C is located on an undeveloped area running north to south for approximately 0.06 along Elm Ave from existing Trail 9 to Warthan Apartments trail.

The Report must also be presented to City Council.

I. RECOMMENDATION:

Adopt Resolution No. 4306 accepting the conveyance of a permanent multi-use trail easement from JRyKO Joint Venture for Segment No. 7 of the Coalinga Multi-Use Trail System and authorize the City Manager to execute all documents necessary to complete the transaction and record the deed.

II. BACKGROUND:

The City of Coalinga is implementing a phased Multi-Use Trail System to enhance pedestrian and bicycle connectivity, promote recreation, and improve public access throughout the community. The trail system is being constructed in multiple segments, with each segment requiring acquisition or dedication of the necessary property interests.

Segment No. 7 is a critical connection within the overall trail network. To facilitate construction and long-term maintenance of this segment, the City negotiated the acquisition of a permanent trail easement from JRyKO Joint Venture, a general partnership, over a portion of Assessor's Parcel Number 071-020-58S.

III. DISCUSSION:

The City and JRyKO Joint Venture entered into an Agreement for Acquisition of Property providing for the conveyance of a Permanent Multi-Use Trail Easement associated with Segment No. 7. The easement area contains approximately 15,075 square feet, more or less, and is legally described and depicted in the attached exhibits prepared by Tri City Engineering.

The City Council previously approved Resolution No. 4306, authorizing acceptance of the easement and determining that the action is not a project under the California Environmental Quality Act (CEQA) pursuant to California Public Resources Code Section 21065.

A Certificate of Acceptance has been executed by the City Manager, confirming the City's acceptance of the real property interest and authorizing recordation with the Fresno County Recorder.

Acceptance of this property interest:

- Secures the right-of-way necessary to complete Segment No. 7;
- Advances implementation of the City's Multi-Use Trail Master Plan;
- Provides long-term public benefit for active transportation and recreation; and
- Supports grant compliance and future funding opportunities related to trail development.

IV. ALTERNATIVES:

None

V. FISCAL IMPACT:

Funding for the acquisition of the property interest for Segment No. 7 was previously identified and is included within the approved Multi-Use Trail project budget. There is no additional fiscal impact associated with acceptance of the property.





AGREEMENT FOR ACQUISITION OF PROPERTY

This Agreement for Acquisition of Property ("Agreement") is between the City of Coalinga, a municipal corporation (City) and JRyKO Joint Venture, a general partnership ("Grantor"). This Agreement is expressly subject to approval by the City Manager.

Grantor shall execute and deliver to City a Permanent Multi-Use Trail Easement covering a portion of the land associated with APN 071-020-58S ("Land").

The parties to this contract shall, pursuant to Section 21.7(a) of Title 49, Code of Federal Regulations, comply with all elements of Title VI of the Civil Rights Act of 1964. This requirement under Title VI and the Code of Federal Regulations is to complete the United States Department of Transportation (USDOT) Non-Discrimination Assurance requiring compliance with Title VI of the Civil Rights Act of 1964, 49 C.F.R. Parts 21 and 28 C.F.R. Section 50.3.

Additionally, the parties acknowledge and agree as follows: No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity that is the subject of this Agreement.

In consideration of which, and the other considerations hereinafter set forth, which the parties acknowledge is satisfactory, it is mutually agreed as follows:

1. PROPERTY.

Grantor(s) agrees to sell to City, and City agrees to purchase from Grantor(s), on the terms and conditions set forth in this Agreement, the real property interest described in Exhibit A and depicted in Exhibit B attached hereto (which exhibits are incorporated herein by this reference) which is a portion of the Land (such portion, the "Property").

The parties have herein set forth the entirety of their agreement in this Agreement. The performance of this Agreement constitutes the entire consideration for said document and relieves City of all further obligation or claims on this account, or on account of the location, grade or construction of the proposed public improvement (that is, Multi-Use Trail Pedestrian Improvement Project (Segments 1 to 8, inclusive); hereinafter, the "Project").

2. DELIVERY OF DOCUMENTS/ESCROW.

Grantor shall execute and deliver to the City's designated acquisition agent all documents necessary for the transfer of the Property, including without limitation this Agreement, the Deed(s) and/or the Easement(s). Subject to City's approval, such documents are to be delivered to Escrow Holder (defined below).

This transaction shall be handled through an escrow with Chicago Title Company ("Title Company" or "Escrow Holder"), located at 7330 N. Palm Avenue, Suite 101, Fresno, CA 93711, Phone No. (559) 451-3700; Escrow No.: 45005579-450-SM-MW1 ("Escrow"). Close of Escrow is to occur upon, among other things, the recording of the Permanent Multi-Use Trail Easement Deed and the release of the Purchase Price by Title Company or Escrow Holder, as appropriate.

3. PURCHASE PRICE AND TITLE.

The consideration to be paid by the City for the Property is THREE THOUSAND EIGHT HUNDRED DOLLARS (\$3,800.00) ("Purchase Price"). Payment of the Purchase Price is consideration in full for the real property interests being conveyed in the Permanent Multi-Use Trail Easement Deed.

City shall deliver the Purchase Price before the Close of Escrow after the execution and delivery of all necessary transfer documents by Grantor has occurred. Grantor shall convey good, marketable, indefeasible and insurable title to the Property free and clear of all liens, encumbrances, taxes, assessments, leases recorded and/or unrecorded, and easements or rights of way over the Land, including without limitation the following: Matters listed as exception item numbers 1 through 9 paid current, and 10 through 20, contained in that certain Preliminary Title Report No. 45005579-450-SM-MW1, dated August 6, 2024, prepared by Title Company ("Preliminary Report"). In all other respects, the Property is to be sold in its "as-is," "where is" condition, without any representations or warranties by Grantor regarding the Property's fitness for any particular purpose, use, condition, or compliance with laws and regulations (except as otherwise expressly provided in this Agreement; see, for example, Sections 7 and 8 below).

[] Title insurance is not required; or [X] Good, marketable, indefeasible and insurable title to the Property is to be evidenced by a CLTA owner's policy of title insurance ("Title Policy"). The Title Policy is to be in the amount of the Purchase Price (or such greater amount as City requests and Title Company agrees), showing title to the Property vested in City. It is a condition precedent to City's obligations under this Agreement that Title Company is able to issue, and at the Close of Escrow issues or is irrevocably committed to issue, the Title Policy to City. Therefore, Grantor shall provide (that is, execute and deliver to Title Company) any Owner's Affidavit or Seller's Statement customarily, usually and/or reasonably required by Title Company in connection with same; and Grantor as well as City will execute and deliver any customary, usual and/or reasonable supplemental escrow instructions required by Escrow Holder; provided, however, that such instructions must not be contrary to the terms of this Agreement or increase any party's obligations, liabilities or duties under or pursuant to or as contemplated by this Agreement.

City shall pay all costs Escrow, title insurance, and recording fees incurred in this transaction other than the costs and expenses of any special or other services requested for or on behalf of Grantor; Grantor shall be solely responsible and liable for any such special or other services.

Grantor agrees that if claims are submitted by lienholders, or if there are liens of record as shown on the Preliminary Report, those claims and or liens must be satisfied and deducted from the Purchase Price to be paid to Grantor by the Escrow Holder through the Escrow. Any such claims or liens are to be shown on seller's estimated closing statement provided to Grantor by the Escrow Holder. Since the Property is comprised of a portion of a larger parcel (that is, the Land), partial reconveyances for any deeds of trust must be obtained from the applicable lender or lenders (if necessary, in return for paying down the indebtedness attributable to the Property through the Escrow) and recorded through the Escrow.

Grantor acknowledges that the acquisition of the Property by the City (for the Project) is for a public purpose, and therefore, the Property is otherwise subject to taking by the power of eminent domain. Grantor acknowledges that in lieu of condemnation, the Purchase Price to be paid under and pursuant to this Agreement constitutes full and fair compensation and consideration for any and all claims that Grantor has or may have against the City by reason of the acquisition, improvement, possession, use and/or occupancy of the Property, including, without limitation, any and all claims for attorneys' fees, pre-condemnation damages, severance damages, or any other claims; and, therefore, the parties agree as follows:

FULL AND COMPLETE SETTLEMENT IN LIEU OF CONDEMNATION; WAIVER OF DAMAGES: Grantor and City acknowledge and agree that this Agreement, including without limitation the transaction(s) set forth in or contemplated by this Agreement, is (are) a negotiated settlement in lieu of City exercising its power of eminent domain. Grantor and City further acknowledge and agree that City is acquiring the Property under the threat of the power of eminent domain. Grantor acknowledges and agrees that City's acquisition of the Property for the Project is a valid public use. Grantor hereby acknowledges that the compensation paid to Grantor under, through and/or pursuant to this Agreement constitutes the full and complete settlement of any and all claims against City related to City's acquisition of the Property, including but not limited to full payment of just compensation in eminent domain by reason of City's acquisition of the Property, specifically including, but not limited to, any and all rights or claims that Grantor has, may have or may in the future have under Article 1, Section 19 of the California Constitution, the Eminent Domain Law (California Code of Civil Procedure, Part 3, Title 7, commencing with section 1230.010), or any other law or regulation, except as provided herein. GRANTOR, ON BEHALF OF ITSELF AND ITS SUCCESSORS AND ASSIGNS, INCLUDING WITHOUT LIMITATION ITS SUCCESSORS-IN-INTEREST, FURTHER KNOWINGLY AND VOLUNTARILY WAIVES AND EXPRESSLY RELEASES AND DISCHARGES CITY AND ANY AND ALL OF CITY'S EMPLOYEES, AGENTS, OFFICERS, SERVANTS, REPRESENTATIVES, CONTRACTORS, SUB-CONTRACTORS (OF ALL TIERS) ATTORNEYS, PARTNER AGENCIES, SUCCESSORS AND ASSIGNS, FROM LIABILITY IN REGARD TO ANY CLAIMS

4. IMPROVEMENTS PURCHASED AND COST TO CURE.

Payment in Clause 3 includes, but is not limited to, payment in full for all the land, real property interests, improvements, damages, severance, benefits, loss, replacement and moving of any improvements, that are considered to be part of the realty and are being acquired by the City in this transaction as conveyed by the Deed. The price did not include the purchase of any improvements.

Also, included in the amount payable under Clause 3 is payment in full to compensate Grantor for the expense of performing the following work: The price did not include the purchase of any improvements.

5. PROPERTY TAXES AND ASSESSMENTS.

Seller shall timely pay all real property taxes and assessments allocable to the Master Parcel accruing prior to Close of Escrow. Because Buyer is a public agency to whom real property taxes do not apply, no proration of real property taxes will be made through Escrow. Seller will have the right to file for and receive a refund of general and special real property taxes and assessments previously paid by or on behalf of Seller with regard to the Property, which become refundable due to Buyer's status as a public agency. Buyer will cooperate reasonably with Seller's efforts to obtain any such refund.

6. PERMISSION TO ENTER.

Upon execution and delivery of this Agreement by Grantor, Grantor hereby grants to City, its agents and contractors, permission to enter upon the Land, including without limitation the Property, prior to the Close of Escrow. Entry is to be for the purposes of topographic field surveys, environmental investigation and geotechnical investigation purposes only, and subject to all applicable terms and conditions contained in this Agreement and the associated Permanent Easement Deed.

7. POSSESSION.

Grantor agrees that after the City's acceptance of this Agreement, including without limitation the applicable Deed(s) and/or Easement(s) and, upon or after the establishment and opening of Escrow occurs, the date payment (that is, the Purchase Price) is deposited by City into Escrow constitutes the date of possession as well as upon and after which the City may irrevocably enter upon and take as well as continue possession of the Property, notwithstanding the failure of the Close of Escrow to occur, including in the event of termination of this Agreement.

8. LEASE INDEMNIFICATION.

Grantor represents and warrants to and for the benefit of City, its successors and assigns, including without limitation its successors-in-interest, that there are no oral or written leases on all or any portion of the Property exceeding a period of one month. And, if there are any leases not exceeding one month, Grantor shall terminate any such leases prior to

If there is (are) (i) any lease(s) exceeding one month, or (ii) any lease(s) not exceeding one month that are not terminated prior to the Close of Escrow, then Grantor shall hold harmless and reimburse City for any and all claims, demands, losses, liabilities, damages, costs and expenses, including without limitation attorneys' fees and costs, arising out of, resulting from, related to or otherwise occasioned by reason of any such lease(s) of the Property by a tenant (or tenants).

9. HAZARDOUS WASTE MATERIAL.

Grantor hereby represents and warrants to and for the benefit of City, its successors and assigns, including without limitation its successors-in-interest, that during the period of Grantor's ownership of the Land, including without limitation the Property, there have been no disposals or releases of hazardous substances on, from, or under the Land or the Property. Grantor further represents and warrants to and for the benefit of City, its successors and assigns, including without limitation its successors-in-interest, that Grantor has no knowledge of any disposal or release of hazardous substances, on, from, or under the Land or the Property which may have occurred prior to Grantor taking title to the Property.

Grantor acknowledges and agrees that the Purchase Price of the Property reflects the fair market value of the Property without the presence of contamination. If the Property is found to be contaminated by the presence of hazardous substances which requires mitigation under Federal or State law, City reserves the right to recover its clean-up costs from those who caused or contributed to the contamination, or who may be otherwise deemed responsible parties.

10. ENTIRE AGREEMENT.

This Agreement and the attached Exhibits constitute the entire agreement between the parties relating to the sale of the Property, including but not limited to the transfer of permanent and temporary real property interests described herein above. Any prior agreements, promises, negotiations, or representations not expressly set forth in this Agreement are void and of no force and effect. Any amendment to this Agreement is of no force and effect unless it is in writing and signed by the City and Grantor(s).

11. GRANTOR LIABILITY; REAL ESTATE REPORTING PERSON; IDENTIFICATION OF GRANTOR; SURVIVAL; AND COUNTERPARTS.

If Grantor is comprised of more than one person or entity, each of such persons and/or entities is jointly and severally responsible and liable for the obligations, liabilities and duties of Grantor under or pursuant to this Agreement.

Escrow Holder is hereby designated the "real estate reporting person" for purposes of Section 6045 of Title 26 of the United States Code and Treasury Regulation 1.6045-4, and the closing statements or any other any settlement statement prepared by Escrow Holder or Title Company is to so provide. Upon the Close of Escrow, Escrow Holder is to file a Form 1099 information return and send the statement to Grantor as required under the aforementioned statute and regulation.







I. RECOMMENDATION:

Receive and discuss the presentation regarding the proposed comprehensive overhaul of the City's cannabis ordinances, and provide policy direction to staff on any desired changes, priorities, or concerns prior to preparing a final repeal-and-replace ordinance for formal consideration.

II. BACKGROUND:

The City of Coalinga currently regulates commercial cannabis activities through multiple ordinances and sections of the Municipal Code that were adopted incrementally over time. As State cannabis laws, regulatory agencies, and industry practices have evolved, portions of the City's code have become duplicative, outdated, or internally inconsistent.

To address these issues, the City engaged SCI Consulting Group to review the existing regulatory framework and prepare a consolidated, modernized ordinance structure that improves clarity, enforceability, and administrative efficiency while preserving local control over cannabis operations.

III. DISCUSSION:

Overview of Proposed Changes

The proposed update would repeal and replace the City's existing cannabis ordinances with a single, consolidated ordinance governing all commercial cannabis activities. Key objectives include:

- Creating one unified ordinance applicable to all license types
- Harmonizing and clarifying definitions
- Removing outdated references to superseded State laws and agencies
- Streamlining permitting, enforcement, and compliance procedures
- Establishing a clean foundation for future policy decisions

Major Structural Changes

The proposal replaces the current dual-ordinance structure with one comprehensive ordinance, consolidating application procedures, permit requirements, renewals, enforcement provisions, and employee permitting into a single regulatory framework. This approach is intended to reduce redundancy, confusion, and administrative burden for both staff and operators.

The ordinance is reorganized into a streamlined four-part structure:

- Application and Permit Procedures – Unified processes for conditional use permits, regulatory permits, renewals, denials, and suspensions.

- General Operational Requirements – Standard operating rules applicable to all license types (hours, signage, minors, odor control, nuisance prevention, environmental compliance, and recordkeeping).
- Security Requirements – Modernized and standardized security standards, including camera systems, access control, alarms, lighting, monitoring, retention, and backup power.
- Activity-Specific Requirements – Distinct sections for retail, lounges, manufacturing, distribution, cultivation/nursery, and microbusiness operations.

Removal of Duplicative State Requirements

The proposed ordinance intentionally removes provisions that merely restate State law or reference outdated regulatory bodies (e.g., former State agencies or repealed statutes). This approach allows the City's code to focus on local land use, operational, and enforcement standards, while avoiding conflicts with future changes in State cannabis regulations.

Benefits to the City

If implemented, the proposed overhaul is expected to:

- Reduce staff workload and administrative complexity
- Improve code clarity and enforceability
- Provide clearer, more predictable requirements for operators
- Support consistent inspections and compliance efforts
- Reduce interpretation disputes and processing delays

IV. ALTERNATIVES:

- Provide direction to modify the proposed framework before proceeding.
- Direct staff to maintain the existing ordinance structure with targeted amendments instead of a full repeal-and-replace.
- Take no action at this time.

V. FISCAL IMPACT:

The fiscal impact as part of this action is part of the existing work order the City has executed with SCI to undertake this effort.

I. RECOMMENDATION:

City Council is recommended to approve Resolution No. 4305, amending the Gas Purchase Policy to become the Natural Gas Enterprise Policy, thereby establishing sub-funds for Capital Improvement and Rate Stabilization, and making changes to the terms of the existing gas purchase policy.

II. BACKGROUND:

At the request of the city council, the attached resolution provides further structure and fiscal discipline for the management of the city's natural gas enterprise. It is an expansion of the existing gas purchase policy to establish Rate Stabilization and Capital improvement sub-funds.

III. DISCUSSION:

Establishment of Capital Improvement and Rate Stabilization Sub-Funds

The intent of these cash sub-funds within the Gas Enterprise is to set aside, under defined accounting codes, cash that is reserved for capital improvement projects and for rate stabilization. Transfer to and from these sub-funds will be by the authority of the city council. The result will be increased transparency in the use and management of available cash in the gas enterprise and will also serve to avoid rate swings.

Though the approved resolution establishes the two sub-funds, it does not provide available cash to be assigned to them. However, it does suggest the objective amount for Rate Stabilization to be \$500,000 total, and the annual amount for Capital Improvement to be \$250,000 per year.

Proposed Resolution No. 4305 provides more detail on the two established funds.

Changes to Gas Purchase Policy

The following changes have been made to the gas purchase policy to streamline its use and adjust to current gas market conditions.

- The three-year purchase schedule has been removed to allow more discretion to staff (and allow fewer exceptions to the policy) regarding advance purchases.
- The Gas Purchase Policy is amended to be incorporated with the Rate Stabilization and Capital Improvement Funds.

IV. ALTERNATIVES:

Do not implement sub-funds for rate stabilization and capital improvement.

V. FISCAL IMPACT:

The action of adopting Resolution No. 4305 does not have a direct fiscal impact. Subsequent actions by the Council may impact the enterprise funds and/or rates.

RESOLUTION NO. 4305

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COALINGA AMMENDING THE LONG-TERM NATURAL GAS PURCHASE POLICY TO BECOME THE NATURAL GAS ENTERPRISE POLICY AND ESTABLISHING FUNDS FOR CAPITAL IMPROVEMENT AND FOR RATE STABILIZATION

WHEREAS, City operates a municipal natural gas distribution utility beneficial to City residents and businesses; and

WHEREAS, City Council of Coalinga approved implementation of a gas purchase policy in Resolution No. 4156, dated May 4, 2023, then amended by Resolution No. 4231, dated August 15, 2024; and

WHEREAS, City Council has further requested establishment of separate sub-funds within the gas enterprise for Capital Improvement and Rate Stabilization; and

WHEREAS, the Gas Purchase Policy is further amended herein to be simplified for appropriate use under changing market conditions; and

WHEREAS, the previous Natural Gas Purchase Policy is being integrated into this comprehensive Natural Gas Enterprise Policy to incorporate all related policies in one resolution; and

WHEREAS, the intent of this Natural Gas Enterprise Policy is to be reviewed annually and modified when needed to best manage natural gas services within the City of Coalinga; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Coalinga does hereby approve as follows:

Capital Improvement and Rate Stabilization Funds

1. This resolution hereby establishes within the Natural Gas Enterprise Fund two separate sub-funds to be named:
 - a. Natural Gas Rate Stabilization Fund
 - b. Natural Gas Capital Improvement Fund
2. Each sub-fund shall be assigned a distinct asset account number within the city's accounting system.
3. Account balances in each of the sub-funds shall be in the form of available cash.
4. Transfers of available cash into the sub-funds shall be approved by the City Council in conjunction with Annual Reporting. The source of transfers may be accumulated net operating revenue, or it may be revenue from rates set deliberately to provide available cash for the sub-funds.
5. Use of the funds shall be restricted such that approval to utilize available cash held in the funds shall be provided only by the City Council.
6. Capital Improvement Fund. The intent of the Capital Improvement Fund is to be used for capital repair items that are not budgeted as operating costs. Examples are replacement of the anode beds

protecting the steel pipeline system, replacement of distribution pipe and valves, and replacement of gas meters. The objective level of annual funding for the Capital Improvement Fund is \$250,000 per year beginning FY25/26 primarily driven by the replacement cost of two anode beds per year for the next five years at a cost of approximately \$100,000 each.

7. Rate Stabilization Fund. The intent of the Rate Stabilization Fund is to be used to avoid rate increases caused by wholesale gas price volatility, especially price spikes caused by extremely cold winter conditions and transmission pipeline failures reducing gas availability. The objective level of total funding for Rate Stabilization is \$250,000 based on a 25 percent increase over \$1,000,000 in wholesale gas costs. This objective level of funding is greatly reduced by the Gas Purchase Policy requirement of purchasing winter gas prior to each winter.

Gas Purchase Policy

1. City staff shall continue a long-term natural gas purchase policy as modified and defined herein. Staff shall take steps to ensure reasonable pricing for natural gas supply using dollar cost averaging by making gradual purchases over time when appropriate based on market conditions.
2. Winter months for the purpose of the gas purchase policy are defined as November through March.
3. Prior to November of each year, staff shall have purchased at least 80 percent of the average demand for each month of the oncoming winter. The calculation of the average demand shall be updated following each winter.
4. Fixed-price purchases may be made:
 - a. Up to five years into the future, and
 - b. For all months, beyond winter, up to 80 percent of the three-year average
5. The City Manager is authorized to execute gas purchase and transportation agreements as needed for gas supply to the city. The rationale for each purchase shall be documented, including the date of the transaction, volumes, prices paid, market price trends, and market conditions.

Annual Reporting

City staff shall report to the City Council by the end of each September:

1. The results of the City's natural gas supply portfolio through the previous winter
2. Gas purchases and projected gas costs for the next winter
3. The economic state of the natural gas enterprise fund, including revenues, expenses, operating fund balance, and projections
4. The balance of the Rate Stabilization Fund, and activity during the year
5. The balance of the Capital Improvement Fund, and activity during the year
6. Recommended transfers or funding rates for Rate Stabilization and Capital Improvement
7. Recommended adjustments to gas rates
8. Recommended changes or additions to the Natural Gas Enterprise Policy resolution

I. RECOMMENDATION:

Adopt the proposed Clean City Initiative framework and direct staff to implement enhanced enforcement, outreach, and abatement actions as outlined in this report to further the City's Strategic Goal emanating from the City's strategic planning efforts.

II. BACKGROUND:

Community cleanliness and property maintenance are directly linked to public health, neighborhood stability, and economic vitality. Over time, several areas of the City have experienced increased visual blight and deferred maintenance, including vacant and burned structures, accumulation of debris, unmaintained landscaping, and inoperable vehicles visible from the public right-of-way.

Council requested code revisions and enhanced enforcement protocols. Staff was able to include the 2024 International Property Maintenance Code (IPMC) in the requisite adoption of the 2026 California Model Codes. The IPMC codifies minimum habitability, and exterior maintenance standards, while removing ambiguity and vague standards in the California Model Codes making standards less vulnerable to appeal and selective enforcement claims.

The adoption of the 2024 IPMC as well as a robust, logical and well communicated plan to systematically increase enforcement in the City is what staff believes the Council requested. Overall, existing code enforcement tools remain effective, and staff has outlined a more structured, visible, and coordinated initiative that combines enforcement with outreach and clear expectations to meet Council's directive.

III. DISCUSSION:

Staff has developed a robust and logical plan to begin the implementation of the Council's Clean City Initiative. The following underlined sub-headings highlight recommended actions.

Removal of Burned and Unsafe Structures:

Burned-out and structurally compromised residences present ongoing safety hazards, attract illegal activity, and contribute significantly to neighborhood blight.

Staff proposes prioritizing:

- Identification and cataloging of burned or fire-damaged structures
- Continuing coordination with Building, Fire, and Legal staff to determine appropriate abatement paths with a bi-weekly meeting to discuss statuses and next steps

- Continued and vigorous use of existing nuisance abatement authority, including notices, administrative citations, and demolition where warranted. The City **will incur upfront costs**, with cost recovery a long-term, realistic pursuit.

Removal of these structures is expected to have an immediate and measurable impact on neighborhood conditions.

Enhanced Code Enforcement Strategy:

The Clean City Initiative will utilize rotating, targeted enforcement efforts focused on common, observable violations that significantly affect neighborhood appearance and compliance.

Targeted enforcement categories will include in order of priority:

- Accumulation of trash and debris
- Boarded or unsecured residences
- Unmaintained or dead landscaping
- Vehicles parked or stored on unpaved surfaces
- Inoperable vehicles located within front yard setback

Enforcement will rotate by category and geographic area to ensure:

- Consistent citywide coverage
- Manageable workload for staff
- Clear messaging to residents regarding expectations

This “low-hanging fruit” approach is intended to achieve rapid, visible improvements while reinforcing compliance norms.

Community Notification and Outreach:

To support transparency and voluntary compliance, staff recommends the deployment of advance mailers and public notices prior to targeted enforcement periods. Additionally, staff recommends posting rolling messages on the City’s electronic and social media platforms. This outreach-first approach supports fairness and reduces enforcement resistance. Outreach tools may include:

- Citywide or neighborhood-specific mailers
- Social media announcements and website updates
- Coordination with neighborhood groups or community organizations

Mailers/Outreach will outline:

- Upcoming enforcement focus areas
- Applicable municipal code sections
- Compliance timelines
- Contact information for questions or assistance

Implementation and Staffing

The initiative will be implemented using existing staff and authority, with enforcement intensity scaled based on capacity and observed results. Interdepartmental coordination among Code Enforcement, Building, Police, Fire, and Public Works will be emphasized. Increased staffing will increase results and speed at which results can be expected but is not recommended at this time as plan implementation and community response may change this over time. Adjustments to enforcement focus and outreach methods will be made as necessary.

Staff will track and report to Council:

- Number of violations addressed
- Compliance rates

- Abatement actions completed
- Community feedback

Staff will also track and report Council directed performance measures, and adjust enforcement as directed.

IV. ALTERNATIVES:

- Direct Staff to implement the Clean City Initiative as outlined by staff above (Recommendation)
- Direct staff to not implement changes to current Code Enforcement practices (Not Recommended)

V. FISCAL IMPACT:

The Clean City Initiative is expected to be implemented largely within existing operational resources. Varied costs associated with mailers exist; inserts into utility bills are a less costly outreach method, although staff recommends post card size mailers at a cost of ~\$5k-\$7K per mailer. Additionally, abatement actions, and contracted demolition may be incurred; however, these costs should be largely offset through administrative citations, penalties, and cost recovery where permitted by law.

At this time, staff recommends an initial expenditure of ~\$5k-\$7k for a post-card sized mailer to be mailed to all households and businesses to properly socialize the increased enforcement actions, and address community concerns early.

These improvements are critical to ensuring the continued safe operation of the airport, enhancing its utility for local and regional users, and fostering economic growth in the surrounding community.

The Coalinga Municipal Airport serves as a vital infrastructure asset for our region, providing essential connectivity for general aviation, emergency services, and agricultural operations. To maintain its functionality and safety standards, the following improvements are urgently needed:

Runway Reconstruction: The current runway infrastructure has deteriorated significantly over time and requires comprehensive reconstruction to meet FAA safety standards and support the volume and types of aircraft utilizing the airport.

Weather System Improvements (AWOS): Installation of a new Automated Weather Observing System (AWOS) that will provide accurate, real-time weather information to pilots, enhancing flight safety and operational reliability.

Lighting Improvements to LED: Upgrading the airport's existing lighting systems to energy-efficient LED technology will improve visibility during low-light conditions, reduce energy costs, and align with sustainability goals.

New Hangar Construction: The construction of new hangars will address the increasing demand for aircraft storage, support operational growth, and generate additional revenue for the airport.

New Fueling Systems: The installation of modern fueling systems is necessary to replace outdated equipment and ensure reliable fuel availability for all types of aircraft. This upgrade will enhance operational efficiency, improve safety, and support increased aviation activity at the airport.

The operation of the New Coalinga Municipal Airport

Priorities:

1. Runway Reconstruction of the main runway is a priority for the City of Coalinga. The challenge faced by Elected Officials and leadership is the airport is a general fund expense. The decision must be made between funding airport projects or funding essential services such as public safety. The continued operation of the airport is essential for regional access to the far west side of the county. The airport provides services for general aviation, access for agriculture in the area, and emergency services along with access to the Pleasant Valley State Prison and Coalinga State Hospital in the area. In recent inspections the condition of the runway has been noted. The crosswind runway condition is poor and had to be closed to operations. The main runway is getting close to its useful life and needs to be reconstructed.
2. New Fueling System is a highly needed at the airport. The current system is obsolete. Fuel is a critical component of any airport. Traffic volume increases with the availability of fuel. No fuel service available has been noted on the last several inspections of the airport. The City is seeking funding for a new fueling system with access to No-Led and Jet Fuel.
3. Constructing New Hangers is an element necessary for the growth and expansion of the airport. With the construction of new hangars, the Airport could work on attracting other aviation related business to be based at the airport. The waiting list has been in use and has had very little movement. There are currently thirteen on the list waiting for hangers. These include the personal use hangers and possible flight school business who have shown interest in locating to Coalinga's airport based on its location and lack of fog.

4. Automated Weather Observing System (AWOS). Having a weather reporting system providing real-time weather is important for pilot's safety especially in the pleasant valley where weather patterns, especially wind, can be significantly different than in the areas of Hanford and Lemoore where the main source of weather is reported. These City's are 30-40 miles away from Coalinga. The system helps pilots navigate the weather conditions they will be entering. The system previously in operation is outdated. The parts and technical assistance are no longer available to provide support for the system. The inoperable AWOS has been noted in recent airport inspections.
5. Lighting Improvements are an upgrade needed to the current system. Energy-efficient LED technology and smart lighting controls that adapt to weather conditions could be installed. Installation of LED and other lighting controls would enhance visibility and are critical to ensure pilot safety.

The New Coalinga Municipal Airport has several infrastructure projects that align well with available federal and state funding opportunities. Key projects including the runway rehabilitation and design, AWOS installation, lighting improvements, airfield signage, and apron pavement reconstruction are strong candidates for funding under the FAA's Airport Improvement Program (AIP) and the Infrastructure Investment and Jobs Act (IIJA) Airport Infrastructure Grant, both of which support safety, runway, and airfield upgrades.

These same projects are also eligible for California's AIP Matching Grant, provided they are included in the current Capital Improvement Plan (CIP), which they are. Additionally, the AWOS system, lighting upgrades, and signage qualify for the California Annual Credit Grant, which offers annual funding for general aviation airports. Projects such as the new fueling system and hangar construction, while not eligible under AIP, may be supported through California Airport Loans, which provide financing for general aviation services and can also be used to meet local match requirements for federal grants. Overall, the airport's proposed improvements are well-positioned to leverage multiple funding streams to enhance safety, capacity, and operational efficiency. The City expects to apply for such funds should congressional funding not be available.

City of Coalinga Federal Appropriations Earmark Project Requests – Updated 11/20/2025

WATER, SEWER, GAS, UTILITIES

1. **\$1.50 Million | Water Treatment Plant Filtration System Improvements** – This project consists of constructing new filtration system improvements (including, but not limited to): filter underdrains, washwater collection troughs, air scour equipment, and installation new granular filtration media. Scope of work generally consists of process/mechanical-, site civil-, electrical-, and instrumentation/controls improvements to accommodate the new filtration system improvements.

Project Need: Filtration media in several filters was determined to be inadequate for filtration of clarified water from the upstream flocculation/sedimentation basins. Furthermore, construction of new filter underdrains, wash water collection troughs, and air scour equipment are required to properly maintain filtration- and backwash functionality of each filtration system. Improvements to each filtration system are critical to maintaining adequate production of potable water for the City of Coalinga's customers.

2. **\$2.24 Million | Water Treatment Plant Wash Water Tank Replacement** – This project consists of constructing a new 300,000-gallon wash water supply tank to backwash each of the treatment plant's multimedia filtration systems. Scope of work generally consists of process/mechanical-, site civil-, electrical-, and instrumentation/controls improvements to accommodate the new 300,000-gallon wash water supply tank.

Project Need: The existing 300,000-gallon wash water supply tank is leaking water and at risk of failing due to poor construction, outdated seismic design considerations, and elevated infrastructure age (tank is currently more than 50 years old). Construction of a new wash water supply tank is required to ensure that each multimedia filtration system can be properly backwashed to allow the treatment plant to continue producing potable water. Implementation of this project is critical to maintaining adequate production of potable water for the City of Coalinga's customers.

3. **\$2.25 Million | Water Treatment Plant Sludge Drying Bed Improvements** – This project consists of constructing sludge drying bed improvements (including, but not limited to): drying bed underdrain piping replacements, subgrade-gravel replacement, filtrate

drainage collection equipment, and any additional required structural reinforcement of drainage collection equipment. Scope of work generally of process/mechanical-, site civil-, electrical-, and instrumentation/controls improvements to accommodate the new sludge drying bed improvements.

Project Need: Existing sludge drying bed media was determined to be inadequate for properly separating water from solids conveyed to each of the drying beds. This results in “standing” water that is unable to be filtered and recycled to the first process within the treatment plant. The “standing” (undrained) water results in heavy aquatic plant growth, required treatment plant staff to physically burn or mechanically remove the plant growth on the surface of each sludge drying bed. This could potentially limit the sludge drying capacity of treatment plant if excess sludge needs to be wasted to the drying beds.

4. **\$2.25 Million | Water Treatment Plan Flocculation Basin Rehabilitation** – This project consists of performing rehabilitation of Flocculation-Sedimentation Basins #1 and #2 (including, but not limited to): concrete crack repairs with epoxy injections, application of cement mortar in select areas, replacement of each mechanical clarifier, and any additional structural reinforcement that may be required within the existing basins. Scope of work generally consists of process/mechanical-, site civil-, electrical-, and instrumentation/controls improvements to accommodate rehabilitation of Flocculation-Sedimentation Basins #1 and #2.

Project Need: Flocculation-Sedimentation Basins #1 and #2 were identified to be in critical need of rehabilitation during recent inspections of each basin’s structural and mechanical components. Rehabilitation of both basins is critical to maintaining adequate production of potable water for the City of Coalinga’s customers.

5. **\$1 Million | Water System SCADA Upgrades (outlying areas)** – This system is the backbone to communicating with the peripheral pumps and reservoirs in the City’s water transmission system. The existing control system suffers from communications failures and the main components of the system including programmable controller and radio system are no longer available or supported. This system allows the City to view tank levels, flows and notify operators of errors and major equipment failures which is critical to providing safe and reliable drinking water to the community. Troubleshooting and repairs, if possible, are extremely difficult and expensive to do which can lead to delays in responding to or being notified of major issues in the transmission system.

Project need: The new system will replace the Programmable controllers, reprogram the systems, and include a new cellular based communication system. It will be monitored by the new SCADA system at the water treatment plant which the City recently completed at the cost of \$1.5 million.

\$1.25 Million | Coalinga Critical Gas Mainline Replacement This project consists of replacing approximately 3,850 linear feet (0.73 miles) of the City's highest-risk, leak-prone natural gas distribution mains and associated customer service lines, including but not limited to: abandonment and removal of vintage cast iron and unprotected bare steel pipe; installation of new high-density polyethylene (HDPE) pipe; transfer or renewal of all customer services; installation or replacement of excess flow valves, curb valves, and regulators as required (\$183,300 dedicated line item); hydrostatic pressure testing; tie-ins to the existing system; and complete surface restoration (asphalt paving, concrete sidewalks, curb/gutter, and landscaping). Scope of work generally consists of pipeline replacement, safety device upgrades, site civil/roadway restoration, traffic control, and minor instrumentation/controls improvements required to integrate the new facilities into the City of Coalinga's natural gas distribution system.

Project Need: The targeted 3,850 linear feet of cast iron and bare steel and cast iron mains represent the highest-risk segments identified in the City's PHMSA-compliant Distribution Integrity Management Plan (DIMP), recent leak survey records, and risk-ranking model. These segments have experienced multiple Grade 1 and Grade 2 leaks in the past five years, exhibit advanced external corrosion and graphitization, and pose the greatest threat to public safety in the system. Replacement of these critical mains is essential to eliminate ongoing methane emissions, significantly reduce the probability of incidents or service disruptions, enhance system reliability, and continue providing safe, environmentally responsible natural gas service to Coalinga's residents, schools, hospital, and commercial customers.

AIRPORT

\$1.50 Million (Update to Costs Underway) | Runway Rehabilitation and Design This project consists of a full reconstruction and rehabilitation of the Coalinga Municipal Airport's main runway, including design, engineering, pavement reconstruction, subgrade improvements, grading, drainage, and associated airfield markings. Improvements will restore structural integrity to the runway and extend its useful life for long-term operations.

Project Need: The airport's primary runway is nearing the end of its useful life and has shown deterioration in recent inspections. The crosswind runway has already been closed due to unsafe conditions, making rehabilitation of the main runway critical to continued operations. A full reconstruction is necessary to meet FAA safety standards, ensure reliable aviation access for general aviation, agricultural operators, emergency services, and regional agencies such as the local State Prison and State Hospital, and support future growth of aviation-related activity.

\$600,000 | New Fueling System - This project installs a modern aviation fueling system capable of providing Jet A fuel, replacing outdated and nonfunctional equipment.

Improvements include new tanks, pumps, monitoring components, and a secure, self-serve fuel island with point-of-sale technology.

Project Need: Fuel availability is one of the most significant factors influencing aircraft traffic and airport utilization. The airport's current fueling system is obsolete and has repeatedly been flagged during inspections. Restoring reliable fueling service is essential to supporting general aviation, flight training, agricultural aviation, emergency response agencies, and long-distance aviation traffic. The project will also generate operable revenue and enhance the airport's competitiveness.

\$1.20 Million | New Hangar Construction - This project includes constructing new aircraft hangars to support aviation growth, business attraction, and increased aircraft storage capacity. Improvements consist of site grading, utilities, concrete foundations, vertical hangar construction, and lighting/security systems.

Project Need: Demand for hangar space significantly exceeds supply, with 13 individuals already on a waiting list. New hangars are essential to supporting general aviation users and attracting aviation-related businesses, including flight schools and maintenance operators who have expressed interest in locating at Coalinga's airport due to its favorable flying conditions and minimal fog. Additional hangars will increase airport revenue, stimulate economic development, and expand airport-based services.

\$200,000 | Automated Weather Observing System (AWOS) - This project installs a new FAA-approved Automated Weather Observing System (AWOS) to provide continuous real-time weather data to pilots and aviation service providers. Work includes equipment procurement, installation, calibration, and integration with national weather reporting systems.

Project Need: Coalinga's previous AWOS system is inoperable, outdated, and no longer supported by manufacturers. Without AWOS, pilots must rely on weather reports from Hanford or Lemoore—30 to 40 miles away—creating unsafe discrepancies due to unique local wind patterns in the Pleasant Valley. Reestablishing AWOS is critical for improving flight safety, emergency operations, and nighttime and low-visibility conditions while ensuring FAA compliance and restoring lost operational capability.

\$100,000 | Lighting Improvements and Airfield Signage - This project upgrades the airport's airfield lighting and signage to energy-efficient LED systems. Improvements include runway and taxiway lighting replacement, illuminated signage, electrical upgrades, and smart lighting controls that adjust to weather and ambient conditions.

Project Need: Existing airport lighting is outdated, inefficient, and inadequate for current safety standards. Upgrading to LED lighting will improve nighttime visibility, enhance pilot safety, reduce maintenance costs, and extend system reliability. Lighting

has been identified in multiple inspections as an area requiring modernization, and improvements will support compliance with FAA guidance for general aviation airports.

I. RECOMMENDATION:

Receive information and provide direction regarding potential participation by City officials in a Washington, D.C. advocacy trip in 2026 focused on federal earmark and legislative priorities, coordinated with the City's federal lobbying firm, Townsend Public Affairs.

II. BACKGROUND:

The City of Coalinga retains Townsend Public Affairs to assist with federal legislative advocacy, including pursuit of Community Project Funding (earmarks) and other federal funding opportunities. As part of this effort, the City had identified, at a previous meeting, priority projects for federal consideration and is preparing for the 2026/2027 earmark cycle.

Direct engagement with members of Congress and their staff is an important component of successful earmark advocacy. In that context, City staff has begun preliminary discussions with Townsend Public Affairs regarding the potential timing of a Washington, D.C. trip in 2026.

III. DISCUSSION:

Townsend Public Affairs has advised that early to mid-March 2026 would be an optimal timeframe for a Washington, D.C. visit. Based on prior federal cycles, Congressman Gray's earmark submission deadline in 2025 was April 21, making March an effective window for in-person advocacy ahead of final submissions.

The attached 2026 U.S. House of Representatives calendar shows that the House is scheduled to be in session during the first week of March, as well as the week of March 16, which would allow for meetings with congressional offices while members are in Washington, D.C.

Townsend Public Affairs has identified the following preliminary considerations for Council discussion:

- **Timing Options:**
 - First week of March 2026 (preferred for earmark advocacy)
 - Week of March 16, 2026 (also viable, but coincides with the National League of Cities Congressional Conference).
- **Purpose of Trip:**
 - Advocate for the City's federal earmark requests and legislative priorities
 - Meet directly with members of Congress, committee staff, and federal agencies

- **Coordination:**

- Meetings and schedules would be coordinated by Townsend Public Affairs in advance
- Final project messaging and briefing materials would be prepared prior to travel

Staff is seeking Council input regarding interest in participation, preferred timing, and whether there is interest in aligning the trip with the National League of Cities Congressional Conference or pursuing a stand-alone advocacy visit.

IV. ALTERNATIVES:

None at this time. Staff is seeking direction from Council.

V. FISCAL IMPACT:

No fiscal impact at this time. Any future travel expenses associated with a Washington, D.C. trip would be brought back to the City Council for consideration and approval as part of a future agenda item.

II. BACKGROUND:

Mayor Vosburg has requested that the City Council consider establishing an ad hoc committee to formally support communication and coordination with public and private agencies, including but not limited to the school district, hospital board, and local nonprofit organizations.

III. DISCUSSION:

The proposed ad hoc committee would consist of the Mayor, Mayor Pro Tem, and one alternate Councilmember, along with the City Manager and rotating staff members as needed at the direction of the City Manager. The committee would serve in an advisory capacity only, with no independent decision-making authority. Any recommendations or action items generated by the committee would return to the full City Council for discussion and formal approval.

The intent of the committee is to provide a Council-authorized structure for outreach and coordination with external agencies while maintaining transparency and compliance with applicable open meeting laws. The establishment of this committee would not restrict individual Councilmembers from continuing to meet independently with community organizations or stakeholders.

If approved, the committee would be established and then staff would come back on on January 22, 2025 with an official policy for the council to approve, however, at the discretion of the Council, the council can permit meetings to occur with stakeholders with the City Manager in the meantime so to not delay ongoing policy efforts with stakeholders.

I. RECOMMENDATION:

City Council to review the submitted applications for the vacant City Council seat created by the resignation of Councilman Hedgecock, conduct applicant interviews per the adopted procedure, and consider appointment of one candidate to fill the vacancy effective January 8, 2025.

II. BACKGROUND:

On December 10 2025, City staff publicly announced the vacancy and solicited applications for interested residents through, posting on the City website and social media platforms, publication at City Hall and other public posting locations throughout the City.

The application period closed on December 30, 2025, and as of that deadline, the City Clerk received three (3), completed applications. All eligible applicants have been notified and invited to attend the January 8, 2026, City Council meeting, where interviews will be conducted pursuant to the adopted procedures.

III. DISCUSSION:

Per City Council direction and adopted process in the Code of Conduct, interviews will proceed as follows:

Pre-Interview Verification

- Only timely, complete applications are eligible.
- The City Clerk has verified eligibility per state law.

Interview Order and Notification

- Order determined by random drawing.
- Applicants were notified at least 72 hours prior to the meeting.

Interview Format

- Opening Statement: Up to 5 minutes.
- Council Questions: Councilmembers may ask questions; consistent questioning is encouraged.
- Audience Questions: Up to 10 minutes total; one question per individual.
- Closing Statement: Up to 3 minutes.

Public Comment

- Up to 2 minutes per speaker before deliberation.

Council Deliberation and Voting

- Each Councilmember may nominate one applicant.
- Voting proceeds by voice vote; in case of a tie, the lowest-supported nominee is eliminated and voting continues until a majority is reached.

Appointment and Swearing-In

- The selected applicant may be sworn in immediately following the vote, anytime after the meeting by the Clerk or at the next scheduled Council meeting.

Documentation

- The City Clerk will maintain the official record of all interviews, deliberations, and the final vote.

Term of Appointment

- The appointed individual will serve the remainder of the unexpired term, through November 2026.

IV. ALTERNATIVES:

Special Election: The City may call a special election to fill the vacancy. The City Attorney previously estimated this option to cost approximately \$40,000 and extend well beyond the statutory 60 day period.

V. FISCAL IMPACT:

None determined at this time.
