2. AWARDS, PRESENTATIONS, APPOINTMENTS AND PROCLAMATIONS

1. Employee of the Month for September 2022, Account Clerk III Donna Wright

Finance Supervisor Yasmin Gonzalez presented Account Clerk III Donna Wright with an Employee of the Month certificate for September 2022.

Mayor Ramsey announced that Aera representatives were not able to attend the meeting tonight to accept the certificate. Mayor Ramsey read the Certificate of Recognition into the record.

3. CITIZEN COMMENTS

The following individual(s) spoke under Citizen Comments:

Mrs. Hilda Crawford with the Coalinga-Huron Library District announced that the Library has unfortunately cancelled the Fall Market due to the extreme heat.

Mrs. Crawford suggested the City drain the fountain located outside the front doors of City Hall as it will draw mosquitos.

Mr. Knox Bronson spoke in opposition of removing the Community Garden (Item No. 5.13).

Mr. Michael Gabel spoke in opposition of removing the Community Garden (Item No. 5.13).

Ms. Alma Sanchez spoke in opposition of removing the Community Garden (Item No. 5.13).

Ms. Fern Corey spoke of on-going violence in her neighborhood against herself, her family and stray animals. Ms. Corey, referencing the water conservation efforts and fines, inquired about the particulars of what is allowed and not allowed.

Mr. Nathan Vosburg spoke against the construction companies watering the ground at the construction sites for the Warthan apartment expansion and the Pacific apartment projects when the residents are not allowed to water their front yards.

Mr. Vosburg spoke in opposition of restricting the installation of turf in front yards for all new development (Item No. 5.5).

Mr. Vosburg spoke in opposition of removing the Community Garden (Item No. 5.13).

Mrs. Mary Jones spoke in opposition of removing the Community Garden (Item No. 5.13).

Mrs. Jones asked the Council to show the same voracity with the City's water issues as they did when they fought against the governor during the pandemic.

Assistant City Manager Sean Brewer gave a brief overview of the item stating this item had been continued from the previous meeting. Changes taken from Council direction at the previous meeting have been highlighted.

6. ORDINANCE PRESENTATION, DISCUSSION AND POTENTIAL ACTION ITEMS

1. Discussion, Direction and Potential Action regarding Measure J Renewal
Marissa Trejo, City Manager

City Manager Marissa Trejo gave a brief overview of the item, stating that this was a Future Agenda Item by Councilman Adkisson.

Councilman Adkisson spoke in support of renewing Measure J for an additional 10-year period. It is too late to put the Measure on this election, but he would like to see it brought back so that it can be added to the next election in 2024.

*Consensus of the Council is to **Table** the item until the City Attorney investigate how early the City Council can approve a resolution for the measure to be placed on the 2024 ballot.*

2. Discussion, Direction and Potential Action related to Adding Stop Signs and Various Safety Improvements at the Intersection of Hayes/Harrison/3rd Street
Sean Brewer, Assistant City Manager

Assistant City Manager Sean Brewer gave a brief overview of the item, stating that this was a Future Agenda Item by Councilman Ramirez.

*Consensus of the Council is to **Approve** Option B and to add a few additional safety features as suggested by the City Council.*

3. Discussion, Direction and Potential Action related to a Gray Water Rebate Program
Sean Brewer, Assistant City Manager

Assistant City Manager Sean Brewer gave a brief overview of the item, stating that this was a Future Agenda Item by Mayor Pro-Tem Singleton.

Consensus of the Council is for staff to draft a Residential Gray Water Rebate Program and a Commercial Gray Water Rebate Program for Council's consideration at a future meeting.

4. Discussion, Direction and Potential Action related to Amending Resolution No. 4112 Reinstating a Moratorium on Swimming Pools and Spas Unless Outside Water can be Provided
Sean Brewer, Assistant City Manager

Assistant City Manager Sean Brewer gave a brief overview of the item, stating that this item was being brought back for further discussion.

City Manager Marissa Trejo pointed out that the City did receive one public comment regarding this item from a Mr. Jeremy Yarbrough and a copy has been provided by the City Clerk.

Consensus of the Council is to allow permitting of new pools if the applicant can provide a copy of their signed contract for outside water and a receipt for that water showing the water has been purchased upfront.

5. Discussion, Direction and Potential Action on the League of California Cities 2022 Annual Conference Resolution
Marissa Trejo, City Manager

City Manager Marissa Trejo gave a brief overview of the item.

Consensus of the Council is for the Voting Delegate or the Alternate Voting Delegate to vote YES on the League of California Cities 2022 Annual Conference Resolution.

6. Presentation on Drought Update
Sean Brewer, Assistant City Manager

Assistant City Manager Sean Brewer gave a brief overview of the item, stating that the United States Bureau of Reclamation (USBR) has granted the City's request for additional allocation of Public Health and Safety water. This additional allocation will help bridge the cap and extend us through mid to late November, however we will still need to purchase water in order to get through the remainder of the water year that ends February 28, 2022.

Mr. Brewer commented on the odor and color of the water that residents have been experiencing. He assures all that the water is safe to drink. There are several reasons why this occurs, one of which is related to the decrease in water being used. The water stays in the pipes longer and moves slower through them. Staff recommends moving all resident's one day per week watering of trees and shrubs be moved to Mondays. This flushing is necessary and will help to maintain the water quality.

Consensus of the Council is to move the one day a week watering schedule to Mondays for all residents.

7. ANNOUNCEMENTS

City Manager's Announcements:

City Manager Marissa Trejo announced the monthly Chief's Breakfast scheduled for Tuesday, September 6, 2022, has been cancelled.

Mrs. Trejo announced that Finance Director Jasmin Bains has taken a position with another municipality and the position to fill the vacancy has been posted.

Mrs. Trejo announced that the City's street sweeper has retired and City streets are not being swept regularly due to lack of staffing. The sweeping will be intermittent until the position can be filled, therefore there will be no street sweeping charge on the August and September bills.

Council Member's Announcements:

Councilman Ramirez apologized for not making the previous meeting, stating he was in the hospital at the time with a broken shoulder. We are all upset about the City's water situation, and we are all trying to make it better. Mr. Ramirez praised City staff for all their hard work.

Mayor Pro-Tem Singleton announced the high school football team will be playing Selma and the game will be in Coalinga. JV will start at 6:30pm and Varsity will be at 8:00pm.

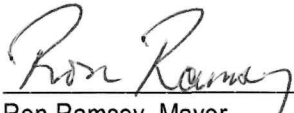

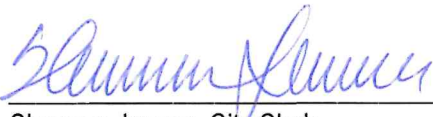

Good evening,

My Name is Jeremy Yarbrough and I have been a resident of Coalinga for approximately 26 years. My wife and I went through the process of designing a pool and securing the financing only to find out that the city imposed a moratorium on pool permits due to the water shortage. After researching when the moratorium was voted on, we discovered we had only missed the opportunity to build our pool by 2 days.

I understand we are in a severe water shortage, and without the assistance of state representatives, Coalinga may run out of water before the end of the year. My family has done everything the city has requested of us to minimize water usage plus some. Our back yard is dirt, many of our faucets have been converted to reduce water, and now we have stopped watering our front yard. This entire process has been depressing as we watch the appearance and value of homes decrease all over town.

As a small compromise, I am requesting that the City Council consider allowing pool permits with the caveat that water to fill the pool is transported from another location. I have researched bulk water delivery and located several companies who will truck water into Coalinga from other sources. Below are a few examples:

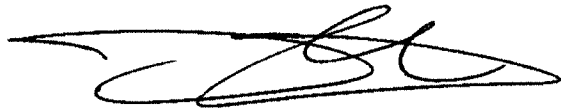
