The Fresno County Film Commissioner has been trying to find activities to bring over to the Westside. There is a company which films a television program in Japan and they have some jail scenes they want to film; they are interested in renting the Claremont Custody Center for this filming. We can get them to spend a little money here in the community in addition to a fee of \$1500 per day. These people from another part of the world will see that we are good people to work with here in Coalinga.

They agreed to a \$1500 per day rental fee. According to the film commissioner, for the Valley that is a good fee. There will be some incidental charges for water and power of \$50 per day.

Lieutenant Ingram has the keys to the facility so he will be the one to open and/or close the facility for them. Periodically, he is going to check on them to see how things are going. They are going to pay his full going rate of \$55.00 per hour. When they are finished, we will send a statement for the duties performed by the Lieutenant.

According to the County Film Commissioner's office and some in the Bay Area, who have worked with them, they are a "stand-up" group.

They have provided liability insurance and we are named "additionally insured".

He just wants to know the determinations and/or feelings of the Council.

I. RECOMMENDATION:

Staff is recommending the Council authorize the City Manager to sign a Facilities Use Permit for the Claremont Custody Center, which will allow the use of the vacant facility for the filming of a television program that airs in Japan. The television production firm will be paying a daily fee, another fee for use of utilities, the fully burden cost of City personnel to open/close and monitor the filming, and they will be providing liability insurance that names the City as an additional insured. It is anticipated the use of the Claremont Custody Center will generate a fee of some \$3,200 for its use over two days.

II. BACKGROUND:

Staff was approached by the County's Film Commissioner's office with a request to use Claremont Custody Center to film scenes for a Japanese television production. The firm representing the Japanese television production company is from the Bay Area, Duo Creative Communications, and has a good track record for representing and following through with other Japanese television or film production firms here in California. Since the facility is vacant, staff felt it was an opportunity to showcase our community, region, our ability to work with others, and to generate a bit of income.

III. DISCUSSION:

Because this type of request is not normal, staff felt it should be brought before the Council for a decision. Recently the Council has been made aware of filming in our area brought over by the County Film Commissioner's office, but this is the first request to use a City facility.

In speaking with the Film Commissioner's office, the going rate for the use of similar public facilities is up to \$1,500 per day, plus other appropriate costs. Staff has a tentative agreement, subject to the Council's approval, for the \$1,500 per day fee, a \$50 per day fee for incidental power, water and sewer use, and the fully burden cost of Lt. Ingham to open and close the facilities and to periodically stop by and monitor the television production crew's work at the facility. Staff understands the production crew will be comprised of seven (7) people and 10 actors. They plan to use the following areas for their re-enactment: the public meeting room, cells, cafeteria area, and outside fence and walls.

IV. ALTERNATIVES:

The Council could decide it is not in the City's best interest to allow the facility's use.

V. FISCAL IMPACT:

Staff anticipates a fee of some \$3,200 for the facility's two day use. This revenue would be attributed to the Claremont Fund and used to reduce the amount owed to the General Fund.
